

# Re-imagining Oregon's Accountability System

**Oregon Department of Education** 

### House Bill 2656

Relating to improvements in student success.

#### **SECTION 3**

- (1) The Superintendent of Public Instruction shall convene an advisory committee to explore options for expanding or revising the education accountability framework in this state.
- (2) The advisory committee convened under this section must include representatives of school districts, teachers' unions and post-secondary institutions of education.
- (3) The advisory committee convened under this section (3) must review accountability programs in other states and make recommendations to the superintendent on the expansion or revision of the education accountability framework.



The desired outcome of any conversation around accountability in education is to ensure resources are appropriately, effectively, and efficiently utilized to produce successful outcomes and experiences for students.
