Braille ELPA Summative Now Available Year-Round

As of school year 2024-25, ordering processes for the braille English Language Proficiency Assessment (ELPA) Summative have changed.

- The braille ELPA Summative may now be ordered at any time during the year. (There is no longer an October ordering deadline.)
 - **Allow at least two weeks for delivery.**
 - Orders two weeks or less from the close of the ELPA Summative test window cannot be honored.
- Braille ELPA Summative training will be posted to the ODE website and available asynchronously.

The [English Language Proficiency Assessment Braille Order Fillable PDF Form](#) has been updated to reflect these changes. The school year has been removed from the form, as it is no longer necessary.

SEED Survey Data Use Professional Learning Series, December 6, 2024

Starting in December, the Oregon Department of Education (ODE) will be offering a monthly drop-in professional learning series that is designed to support Oregon school districts to effectively use and interpret data from the Student Educational Equity Development (SEED) survey.
