TA Assurance Test Security Form Updated

The opening paragraph of the Test Administrator (TA) and Qualified Assessor (QA) <u>Assurance of Test Security Form</u>, found in the Forms pulldown of the <u>Assessment Administration page</u>, has been updated. It now refers users to training requirements in the

TAM rather than restating training requirements. This change simplifies the form and reduces potential confusion over which training requirements apply to TAs as compared to QAs.

SEED Survey Data Use Professional Learning Series, December 6, 2024 REPEAT

Starting in December, the Oregon Department of Education (ODE) will be offering a monthly drop-in professional learning series that is designed to support Oregon school districts to effectively use and interpret data from the Student Educational Equity Development (SEED) survey. The monthly sessions are designed for people who will be working directly with SEED data and data products. However, anyone who is interested is welcome to attend the sessions. Each session will begin with a brief presentation by ODE on a data use topic. The topic for December is unpacking the 2023-2024 SEED Survey State Report. Then, participants will have the opportunity to engage in a community of practice focused on their own experience using and interpreting SEED data.

TEST ADMINISTRATION

2024-25 Alt ELPA User Guide Published

The <u>2024-25 Alternate English Language Proficiency Assessment (Alt ELPA) User Guide</u> is now available on the OSAS Portal and the ELP Assessment page. Important changes from the previous version include:

- · Updated screenshots and formatting
- Updated requirements for the Student Response Check and Early Stopping Rule
- Updated requirements in Appendix B: Alt ELPA Local Scoring
 - Test Administrators (TAs) now need to demonstrate calibration every two years, rather than every year. TAs who demonstrated calibration in 23-24 do not need to do so again in 24-25.

Graduation and Dropout Validations Close Friday

The NCES Dropout and Graduation Rate Validation and the Four and Five Year Cohort Graduation Rate Validations in the <u>Achievement Data Insight (ADI)</u> application close Friday, December 6. Note: ODE is currently processing test data from GED. Data from GED will be loaded into next week's refresh on **December 12**.

If you have not already reviewed your validations, or if you have since made changes to your ADM collection affecting these data, please review these validations before they close.
