School Evaluation

School Evaluation Subcommittee

Rationale:

 The RSAC subcommittee is recommending a staired approach to annual evaluations from ODE. The reason for the three-year plan is to help schools focus on the most important aspects of starting up a school, followed by alignment to goals and building enrollment, with finally moving to a place of visionary planning, and ARS accreditation.

Evaluation Cycle:

 This three-year evaluation cycle format will build on each other, with every third year being an onsite review. This will serve to help support the school in-person in order to be prepared for accreditation, align requirements early on in order to improve the recovery school's outcomes if and when needed, and provide three on-site reviews before the contract renewal with ODE.


