

# Statewide Education Initiatives Account 2025-27 Charter School Equity Grants



## Public Charter Schools Eligible to Apply Directly for Equity Grants

Non-virtual public charter schools that meet specific criteria are eligible to apply for Equity Grants from the Statewide Education Initiatives Account funding under the Student Success Act (SSA) <sup>1</sup>.

These public charter schools must have a student population of which at least 65% of the student population is composed of the following combined student groups:

1. Racial or ethnic groups that have historically experienced academic disparities including American Indian/Alaska Native, Black/African American students, Hispanic/Latino, Native Hawaiian/Pacific Islander, and multiracial; <sup>2</sup>or
2. Students with disabilities who have an Individualized Education Program (IEP) <sup>3</sup>.

Below is a list of eligible public charter schools that may apply for an Equity Grant directly in the Spring of 2025 with funds being available July 1, 2025, ending June 30, 2027.

Data used to determine which public charter schools are eligible to submit a 2025 Equity Grant Application is from the 2023-24 Spring Membership Report and derived from the 3<sup>rd</sup> period cumulative average daily membership collection; and for schools in their first year of operation from the 2024 Fall Membership report derived from the 1<sup>st</sup> period cumulative average daily membership collection and the December 2024 Special Education Child Count Data.

## Required Notice of Intent to Apply for a Charter School Equity Grant

Eligible charter schools interested in applying directly for an Equity Grant in 2025 must give notice to the Department of Education<sup>4</sup>. This notice must include a copy of the charter school's contract for the provision of educational services and funding.<sup>5</sup> An intent to utilize the grant notice will be sent to eligible Charter Schools by March 14, 2025. If any additional schools are identified as eligible through the verified SpEd ChildCount Data in mid-April, a second published notice will be sent out with an intent to utilize the grant notice to eligible schools.

Department requests public charter schools give this notice by noon on Wednesday, March 28, 2025, by completing a Smartsheet form which will be sent to eligible schools.

Application submission date April 30, 2025.

Data in the chart below is from the 2023-24 Spring Membership report derived from the 3<sup>rd</sup> period cumulative average daily membership collection (ADMw) and the 2024 Fall Membership report derived from the 1<sup>st</sup> period cumulative average daily membership collection (ADMw). Preliminary estimated allocations for Year 1 are prorated at 67.6656% to adjust for available funding of \$2,107,000 for 2025-26 SY and are contingent upon the legislative adoptive budget and subject to change. Final allocations for Year 1 will be available in June 2025, after the Legislative Adopted Budget is complete.

Year 2 estimates are for budget purposes only and are subject to funding changes from updated ADMw in Spring 2025 and legislative budget changes. Year 2 budget estimates for 2026-27 reflect funding from Year 1 data. Final updated allocations for Year 2 will be available in June 2026.
