I. BACKGROUND

On August 21, 2023, the Oregon Department of Education (the Department) received a written request for a special education complaint investigation from the parent (Parent) of a student (Student) residing in the Portland School District 1J (District). The Parent requested that the Department conduct a special education investigation under OAR 581-015-2030. The Department confirmed receipt of this Complaint and forwarded the request to the District.

Under state and federal law, the Department must investigate written complaints that allege violations of the Individuals with Disabilities Education Act (IDEA) and issue an order within sixty days of receipt of the complaint.¹ This timeline may be extended if the Parents and the District agree to the extension to engage in mediation or local resolution or for exceptional circumstances related to the complaint.²

On August 31, 2023, the Department's Complaint Investigator sent a *Request for Response* (RFR) to the District identifying specific allegations in the Complaint to be investigated and establishing a *Response* due date of September 14, 2023.

On September 12, 2023, the District submitted a *Response*, stating that while not entirely in agreement with the issues raised, that the District did not contest the allegations described in the Complaint. The District also submitted a proposal for corrective action.

On September 22, 2023, the Complaint Investigator discussed the nature and content of the suggested Corrective Action with the Parent and the Student's Social Worker.

This order is timely.

II. ALLEGATIONS AND CONCLUSIONS

The Department has jurisdiction to resolve this Complaint under 34 CFR §§ 300.151-153 and OAR 581-015-2030. The Parents' allegations and the Department's conclusions are set out in the chart below. The conclusions are based on the Findings of Fact in Section III and the Discussion in Section IV. This Complaint covers the one-year period from June 21, 2022, to the filing of this Complaint on June 20, 2023.

- 4. Appropriately implement or revise the Student's Behavior Intervention Plan to address behavior exhibited by the Student;
- 5. Provide ESY services to the Student; and
- 6. Provide the Parent an opportunity to participate in IEP team meetings related to the development and review of the Student's IEP and BIP, thereby denying the Student a FAPE.

III. FINDINGS OF FACT

- 1. The Student in this case is 11 years of age and attended the fifth grade in a District middle school during the Complaint period. The Student is eligible for special education under the category of Autism Spectrum Disorder (82).
- 2. The District completed the Student's triennial reevaluation on April 28, 2023.
- 3. On August 21, 2023, the Parent filed this Complaint.
- 4. The District provided relevant documents and additional background information relevant to the Student and has considered the allegations made in the Complaint. The Department's Complaint Investigator interviewed the Parent regarding these Complaint issues and the Parent has been apprised of the nature and content of the Corrective Action, as set forth in the Corrective Action table below.

IV. DISCUSSION

The Complainant alleges multiple IDEA violations. While the District provided additional information and expressed some disagreement with the specifics of the alleged violations, the District indicated that it would not contest the allegations.

The Department does not make a substantive determination in the allegations of the Complaint.

Based on the District not contesting the allegations in this Complaint, the Department orders the following Corrective Action:

VII. CORRECTIVE ACTION
