#### FINDINGS OF FACT

- (1) On January 9, 2023, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.
- (2) On January 11, 2023, the Oregon Department of Education (ODE) referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Alison Greene Webster to preside over the hearing in this matter.
- (3) On February 13, 2023, ALJ Kate Triana held a prehearing conference by telephone on ALJ Webster's behalf. Parent participated without counsel. Attorneys Rich Cohn-Lee and Taylor Kinch participated for the District. Pursuant to a Notice of Hearing and Rights issued February 16, 2023, the due process hearing was scheduled for June 5 through 9, 2023 via Webex video conference.
- (4) Via electronic mail received March 13, 2023, Parent notified the OAH that they wished to withdraw the hearing request in this matter.

#### ORDER

Parent's January 9, 2023 request for a due process hearing has been withdrawn. OAH Case No. 2023-ABC-05772/Agency Case DP 23-101 is dismissed without prejudice.
