## FINDINGS OF FACT

- (1) On April 26, 2024, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.
- (2) On April 26, 2024, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Alison Greene Webster to preside over the hearing in this matter.
- (3) On June 27, 2024, attorney for Parent notified the OAH that Parent wished to withdraw the hearing request based on a partial resolution of issues in the due process complaint. Attorney for Parent advised that Parent had conferred with counsel for the District, who did not oppose the motion to dismiss.

### **ORDER**

Parent's April 26, 2024 request for a due process hearing has been withdrawn. OAH Case no. 2024-ABC-06494/Agency Case DP 24-010 is dismissed without prejudice.
