UCF Program Vision












UCF Program Approach



Growing Equity Subaward Program Priorities



Fund outstanding proposals that promote urban and community forest investment and tree equity in overburdened and underserved communities



Support urban and community forestry assessment, planning, and prioritization.





Significantly expand urban and community forestry tree production, planting, and maintenance.

Growing Equity Subaward Program Priorities



Fund outstanding proposals that promote urban and community forest investment and tree equity in overburdened and underserved communities





Support culturally responsive UCF education, engagement, immersive/experiential outdoor recreation, and community-building initiatives





Support urban and community forestry workforce diversification and development.

Growing Equity Subaward Program Priorities



Fund outstanding proposals that promote urban and community forest investment and tree equity in overburdened and underserved communities



Support urban and community forestry monitoring, adaptive management, and lesson sharing



Build capacity with collective impact through an urban and community forestry network.

Subaward Program Details



Funding Period: January 1, 2025 – September 1, 2028.

Funding Ranges: Two funding levels will be available (no match requirement)

- a. Planning, Partnership, Project Development, and Small-Budget Project Subawards (\$10,000 to \$100,000)
- b. Program or Project Implementation Subawards (\$100,001 to \$750,000)

Proposal Submission Period (UPDATED):

- WebGrants registration opens July 1, 2024
- Proposal submission period will be open from July 15 to October 15, 2024 (11:59 p.m., PDT)

Entity Eligibility



1. Eligible Entities (as lead applicant):

- Federally recognized Tribes and Tribal organizations
- Local government entities
- Public and state-controlled institutions of higher education
- Non-profit and community-based organizations

2. SAM.gov & Federal Employer Identification Number:

- Primary applicant must have (and maintain) an active registration in the system for award management (<u>SAM.gov</u>) and have a Unique Entity Identifier (UEI)
- Primary applicant must have a Federal Employer Identification Number (FEIN)









Geographic Eligibility



<u>Match Waiver:</u> 100% of proposed benefits must go to 1) Federally recognized Tribes, or 2) disadvantaged communities.


- Climate & Economic Justice Screening Tool (CJEST)
- Environmental Protection Agency (EPA) IRA
- Title 1-A school campuses
- Other government-sponsored vulnerability tools
 - Geographic eligibility determination will be made by the U.S. Forest Service




Eligible Lands



Funding may be used for projects on non-Federal lands, which include:

- Tribal lands (includes fee and Trust land)
- Private lands (Note: while private lands are eligible, work on private land should provide community benefits, and will require landowner agreement)
- State and local government-owned land
- Homeowner association managed private land






Eligible Costs



Eligible costs are those necessary for developing the program or completing the project(s) incurred during the funding period. Costs must be documented, reasonable and consistent with the project scope.



Ineligible Costs



- Basic research
- Construction and capital improvements (e.g., construction of facilities, roads, new buildings, culverts, or boardwalks)
- Land acquisition
- Cost-share, reimbursement, and other types of payments provided to private landowners
- Small business start-up funding
- Equipment purchases
- Gift cards
- Food or catering services
- Childcare services





Proposal Requirements



You will need:

- ☐ Eligibility information
- □ Applicant and partner information
- □ Program/project information
- Budget information





Evaluation Process



- Proposals will be assessed by the USFS/ODF UCF Programs so that they meet the parameters of the funding opportunity.
- Proposals that meet eligibility requirements will be assessed by review panelists based on five evaluation criteria.

Evaluation Criteria

- 1. Relevance to the UCF subaward program priorities
- 2. Feasibility and clarity of the implementation plan
- 3. Potential impact of the program/project
- 4. Budget realism and cost-effectiveness
- 5. Program/project team experience

2. Subaward Proposal Review

ODF staff notifies applicants of application status and if any opportunity to cure



Review Panel assigned proposals to review and evaluate based on selection criteria



Review Panel convened to assess based on overall merit, geographic distribution, and subaward program priorities



ODF drafts summaries for each proposal with recommendation of funding status and amount

Evaluation Scoring & Notice of Funding



Proposals will be scored using the following scoring system:

- ❖ Each component will be scored on a 1 to 5 scale, with 1 being the lowest and 5 being the highest possible score.
- Review criteria score = average of component scores (for example, Criteria 1 is the average score of Components 1.1, 1.2, and 1.3).
- Proposal overall score = average of review criteria scores.
- Proposals with an overall score greater than 3 will be eligible for funding and will be assessed and ranked relative to other eligible proposals based on overall merit, geographic distribution, and subaward program priorities.

All applicants will be notified in writing of the funding decision within 3 months of submission close date.

Reimbursement & Advance Payment



- ❖ To receive payments from ODF, subrecipients must be registered in OregonBuys and have an active SAM.gov registration status.
- ❖ Funds will be available on a reimbursement basis in accordance with a payment and financial reporting cycle, agreed to in advance. Frequency may be subject to change.
- Advance payments can be requested during the subaward agreement process and award phase. Advance payments will require a payment schedule and a list of anticipated costs before ODF can disburse the funds. ODF will assess and approve requests on a case-by-case basis.
- ODF reserves the right to request additional information prior to approving a payment.

Reports & Monitoring



- Quarterly progress reports will be required to document expenditures and accomplishments in relation to the proposed outcomes.
- ❖ Progress reports should be submitted before the end of each quarter (Quarter 1: March 31; Quarter 2: June 30; Quarter 3: September 30; Quarter 4: December 31).
- Upon conclusion of the subaward, a closeout report will be cooperatively worked on between the ODF and the subrecipient.
- ODF may conduct virtual or in-person site visits and may require copies of subrecipients documents or reports for review.
- Awardees must show progress within the first year. If no progress is documented, ODF may initiate a notice to resume progress or modify the subaward agreement.

Applicant completes subaward eligibility and assistance questionnaire




ODF Technical Assistance available for proposal ideas and reviewing applicant eligibility
