#### **State Forests Division - FPA Compliance Update**

State Forests timber sales, excluding Klamath-Lake District, will now follow the <u>Stewardship Agreement Management Plan</u> which does not change existing timber sale contract language or commitments.

Below, are a few changes of note:

- Notification (NOAP) requirements have been satisfied except for operations including the application of chemicals, the clearing of forestland for conversion to any non-forest use, or the establishment or termination of wildlife food plots.
- The fifteen-day waiting period is satisfied except for operations including the application of chemicals, the clearing of forestland for conversion to any non-forest use, or the establishment or termination of wildlife food plots.
- Neither statutory nor non-statutory written plans are required. However, a plan for an alternative
  practice is required if an activity not covered under the agreement is being implemented Generally,
  Plans for Alternate Practice are not required unless they are outside the scope of the Stewardship
  Agreement.
- Purchasers are required to notify ODF and the Department of Revenue of a timber harvest per ORS 321.550.
- NOAP for Power Driven Machinery Purchasers will need to enter the location information from the Notice Of Timber Sale into the Activity Specific Remarks section in FERNS (e.g. "Portions of Section(s) 28,29 of T9S R8W W.M., Polk Co., Oregon").

POTENTIAL ENDANGERED SPECIES ACT LAWSUIT: The complaint filed by the Center for Biological Diversity and others against the Department of Forestry alleging violations of the Endangered Species Act pertaining to Coho salmon on the Tillamook and Clatsop State Forests has been dismissed. Until issuance of an Incidental Take Permit by NOAA Fisheries, Timber sales identified in the FY 2024 Annual Operations Plans (AOP) and through FY 2028 AOPs will be subject to the Settlement reached in that case that led to its dismissal. Upon issuance of an Incidental Take Permit, the Department and timber sale bidders (and subcontractors) will become subject to terms and conditions of that federal authorization, including any required minimization and mitigation measures proposed in the applicable Habitat Conservation Plan.
