Subject: Preventing COVID, Influenza, and RSV

The Centers for Disease Control and Prevention (CDC) recommends vaccination as a safe and effective way to prevent serious illness, hospitalization, and death related to influenza, COVID, and respiratory syncytial virus (RSV). Please help improve safety and wellbeing in your adult foster home by encouraging residents and caregivers to receive CDC-recommended vaccines.

Why is this Important?

COVID, flu, and RSV have a larger negative impact among older adults and individuals with underlying health conditions:

- Approximately 70% of annual flu deaths occur in adults ages 65 and older.
- Every year, there are an estimated 6,000-10,000 deaths among adults ages 65 years and older due to RSV.
- According to the CDC, most COVID deaths occur in older adults and the risk of death increases with age.

Summary of Recommendations to Prevent COVID, influenza, and RSV Below is a summary of current guidance from the CDC related to these three vaccine-preventable respiratory illnesses.

<u>Influenza</u>

The CDC recommends that people ages 6 months and older receive a flu vaccine every year, ideally before the end of October.

COVID-19

The CDC recommends that individuals 6 months of age and older receive an updated COVID vaccine in the fall of 2023.

Respiratory Syncytial Virus (RSV)

In May 2023, the FDA approved two vaccines for RSV for adults ages 60 and older. The CDC recommends that individuals talk with a doctor to determine if the RSV vaccine should be administered.
