## Updates

### **New Additional Requirements for Memory Care-Endorsed Facilities in 2025**

1. In addition to the resident survey, the CoreQ family survey shall be given to the primary representative listed on the resident's contact list for memory care-endorsed facilities only.
2. The family survey shall include the instruction to respond only if the family member has visited the facility recently enough to provide an informed response.

2. Overall, how would you rate the staff?
3. How would you rate the care your family member receives?
