Intersecting Forms of Oppression

Racism

System of oppression that creates inequities based on race.

Classism


Systems of oppression that creates inequities based on class.

Sexism

Oppression that creates inequities based on gender and/or sex.

Ageism

Systems of oppression that create inequities on the bases of age.



Ableism

System of oppression that create inequities based on disability.

Religion

Oppression based on religious beliefs, practices, and/or affiliations.

Heterosexism

System of oppression that creates inequities based on sexual orientation.

Colonialism

The policy or practice of acquiring full or partial political control over another country, occupying it with settlers, and exploiting it economically.


Immigration Status

Systems of oppression that create inequities on a result of citizenship and or immigration status.
