

TYPES OF ASSISTANCE IN ONE & OREGON ACCESS LTSS BENEFITS

Service Types of Assistance (TOAs) in ONE

- **MSERV, NMAGISERV, LTCSERV**
 - Oregonians receiving LTSS (SPL 1-13), these service TOAs allow payment authorizations to service providers.
 - MSERV
 - This service TOA is seen when an Oregonian is receiving MAGI medical.
 - This is considered a “companion” TOA, meaning it needs a MAGI TOA as well. In the ONE system, the ADLT TOA is commonly seen with the MSERV TOA.
 - NMAGISERV
 - This service TOA is seen when an Oregonian is receiving OSIPM medical.
 - This is also considered a “companion” TOA, and it needs an OSIPM TOA.
 - LTCSERV
 - This service TOA is seen when an Oregonian is receiving OSIPM medical.
 - This TOA is for the Oregonian who qualifies for OSIPM medical benefits under the 300% SSI.
 - This TOA requires the Oregonian to be both service and financially eligible.

SPPC

- **Service Categories/Benefits BPA and BPO**
 - BPA and BPO cannot have an authorized service-related TOA (NMAGISERV or MSERV) in ONE. See [APD-IM-21-053](#) for more information.

- For OPI: Individuals with any TOAs that include OSIPM, or MAGI are not eligible for OPI.

- If there is MAGI compatible service eligibility on file for which no MSERV evaluation is required (BPD, BPM, BPO, DDG, FSG, FSL) ONE will “Pend” the MSERV determination for 45 days to see if new Service Eligibility is established.
- If there is OSIPM compatible service eligibility on file for which no NMAGISERV evaluation is required (BPA, BPM, DDG, FSG, FSL, or OPI) ONE will “Pend” the NMAGISERV determination for 45 days to see if new Service Eligibility is established.
