
• No more Pay Notes!

- DWR holds all info for Payment to the Contractor
- Daily information = more important, but end of the month pay notes do not exist
- DWR's completed offline: Mobile Inspector
 - No service = No Problem
- Immediate shared information, Reports!
 - DWR's from other inspectors are viewable to all, even in Draft form
- Combined Databases
 - QPL, EquipmentWatch, Certifications, and more to come
