Subject: Full Closure and Ramp Closures for Sullivan's Gulch clean up (Portland)

On Sunday, July 14, 2024, the section of I-84 eastbound and westbound between MP 0.0 and MP 5.80, (between I-5 and I-205), and all associated ramps will be closed from 12:00 a.m. (midnight) to 12:00 p.m. (noon). These 12-hour closures are necessary for clean-up, graffiti removal, and maintenance work.

- I-205 NB on-ramp from Glisan St
- I-205 SB Exit 21B to I-84 WB
- I-84 WB Exit 9 off-ramp to I-205
- I-5 SB Exit 301 to I-84 EB
- I-5 NB Exit 299B off-ramp to I-405 NB to upper deck of the Marquam Bridge
- I-405 SB off-ramp to I-5 NB & I-84 EB to upper deck of the Marquam Bridge
- I-84 WB on-ramp from 102nd on ramp
- I-84 WB on-ramp from Halsey St
- I-84 WB on-ramp from NE Glisan St/NE 58th Ave
- I-84 WB on-ramp from Sandy Blvd
- I-84 WB on-ramp from 33rd Ave
- I-84 EB on-ramp from I-5 NB & I-5 NB/I-84 EB on-ramps from Morrison St EB & WB
- I-84 EB on-ramp from Grand Ave/Everett St
- I-84 EB on-ramp from 16th Ave/NE Irving Ave
- I-84 EB on-ramp from Cesar Chavez Blvd
- I-84 EB on-ramp from NE Willow St/NE 60th Ave
- I-5 SB on-ramp from Moda Center (N Weidler St/N Wheeler Ave/N Winning Way)
- I-405 SB on-ramp from Broadway St
- I-405 SB on-ramp from SW 5th Ave
- OR43 NB on-ramp from I-5 NB (ramp to top deck of the Marquam Bridge)

Detour Route Information

When the full closure is taking place, local detours will be signed, but motor carriers should avoid traveling through this area during the restricted days/hours or use authorized alternate routes.

Motor Carriers need to provide this information to their drivers, by copy of this letter or other means, to assure their awareness of the restriction.
