Definitions

- Alcohol-Only Only alcohol was involved in the crashes queried.
- Drug-Only Only drugs were involved in the crashes queried
- Alcohol-Only + Drug-Only Total crashes involving alcohol or drugs, but not both
- Alcohol & Drug-Involved Crash where both alcohol and drugs were involved which can mean:
 - An active participant (i.e. driver, pedestrian, bicyclist) had been using *both* alcohol *and* drugs
 - One active participant had been using alcohol, and another had been using drugs
 - Any such combination as long as both alcohol and drugs were present

What does the data tell us ?

- Crashes involving one or more drugs disproportionately end in death.
- 23% of all fatal and serious injury crashes are substance-involved.
- 65% of all fatalities were from substance-involved crashes.
- Drug-involved crashes are on the rise in Multnomah County.

What does the data tell us ?

 Hood River County had a 67% increase in substance-involved fatalities and serious injuries. (5)

• Washington County had a 19% increase from 2020 – 2021 in substance-involved fatalities and serious injuries.

• Washington County's increase is in single substances, drug-only and alcohol-only in both fatalities and serious injuries.

- Supporting Multnomah County Circuit Court with Initial Alcohol and Drug Evaluation for Indigent DUII Offenders
- Supporting Clackamas County research to develop an effective media campaign on preventing drinking and cannabis use
- Hood River server training and compliance checks
- Hood River Drunk Driving Reduction Pilot Project
