I got into the system easily with those logins and passwords and successfully terminated the lobbyist registrations for myself and Samantha. The one for Mel had previously been terminated. See attached screenshots.

Unfortunately, the system would not let me file quarterly reports early. "No new reports are due at this time," it insisted.

The next and final reports that will be due will be for the first quarter of the year, or Jan-March. Historically, we have received the notification, instructions, and link on the first day of the next quarter, even if it's not a business day (see sample below). They give fifteen days to file. I recommend that Jimmy set a reminder on his calendar to to log in to this electronic system early in April and fill out the forms; that will save him from needing to worry about missing the email notice.

(I also wrote to the address given in the email attached below, asking if they had a mechanism to let us file early; I did not hear back from them and I haven't had a chance to call.)

I respectfully submit this letter of explanation for fines accrued while I was registered as a lobbyist for the Oregon Secretary of State's office in 2016.

As you are probably aware, the Secretary of State's Office went through a leadership transition at the beginning of 2017. The outgoing executive assistant that I worked with submitted my termination paperwork on the first day that the incoming Secretary assumed office, January 4th. However, we were unaware that submitting this paperwork after January 1st, 2017 would effectively make me a registered lobbyist for the first three days of 2017.

Not knowing that I was a registered lobbyist for any portion of 2017, I did not submit a quarterly statement report and I accrued fines from 4/15/17 to 4/25/17 -- on which date Kathy Daniel from your agency contacted me. My email on file (molly.woon@state.or.us) was not active following my departure on 1/4/17 from state employment so I was not receiving notifications about the filing requirements or late fees.

Given these unusual circumstances, I respectfully ask that you dismiss these fines. We were not aware that filing my termination paperwork for 2016 after January 1, 2017 would require a disclosure for 2017. Additionally, I did not receive notice of these requirements until contacted by your office as my contact email was disabled at the conclusion of my state employment.

Dear Members of the Commission,

I write today to provide explanation of my late filings in April 2017 and to seek a waiver of the fines accrued against me. As the staffer for the Oregon Chapter of the Sierra Club that also functions as our lobbyist, I am responsible for filing reports both for myself and for the organization as a whole. In other words, I essentially have to function as both client and employer for the purposes of filing the reports with the Commission.

In about 4 years of lobbying for the Sierra Club, I have never once had a lobbying expense to file with the Commission for myself as a lobbyist. And when I'm filing the report to the Commission on the lobbying time the organization has spent in the quarter, I have to request a timesheet report from our national headquarters in Oakland, California. Typically I try to request that report at least a week before your filing deadline, though sometimes that process is slowed down by the failure of some staff (including myself on occasion) to get their timesheets in.

In April of this year, two things conspired to cause me to file both reports late. First, I mistakenly assumed that when the filing deadline fell on a weekend, the due date would be the first following workday. As you know, April 15 was a Saturday and, perhaps caught up with tax season deadlines, I just assumed I did not need to get the report in until that Monday.

I sent my request to our Oakland HQ on April 11 for the timesheet summary and then followed up on April 13 when I had not heard back from them. Unfortunately, in that April 13 message, I also told our HR department that the report wasn't due to the Commission until Monday (April 17) and asked could they please have the report to me by then. And that, of course, is exactly what happened. By the time I started getting the e-mails from OGEC on Saturday, April 15, that my filing was late and fines were

accruing, our HR staff was out of the office and I was not able to get he report before Monday even if I wanted to.

However, when I did indeed receive the report from Oakland on Monday, April 17, I immediately filed both reports with the Commission. Of course they were technically two days late at that point, resulting in a \$40 fine. And while most organizations and lobbying firms would laugh at a fine of that size, every dollar counts at our small nonprofit. Even though we are a branch of a large national organization, our state chapter budget is all our own and we receive little money from the national group.

Obviously we can and will pay the fine if we have to, but we would certainly prefer to put our members' dollars to better use than paying for an honest mistake that I made. And maybe I'm the only one who made the erroneous assumption that we had until Monday, April 17, to file the reports, but I'd be surprised if so. In any event, the lesson has been learned and I will not make that mistake again. However, I do hope you will accept my explanation for the late filing and decide you can forgive us the fines.

Please accept my apology for the mistake and do not hesitate to let me know if I can answer further questions you may have. Thank you for considering my request and I look forward to hearing your response.



Dear Members of the Commission,

I write today to provide explanation of my late filings in April 2017 and to seek a waiver of the fines accrued against me. As the staffer for the Oregon Chapter of the Sierra Club that also functions as our lobbyist, I am responsible for filing reports both for myself and for the organization as a whole. In other words, I essentially have to function as both client and employer for the purposes of filing the reports with the Commission.

In about 4 years of lobbying for the Sierra Club, I have never once had a lobbying expense to file with the Commission for myself as a lobbyist. And when I'm filing the report to the Commission on the lobbying time the organization has spent in the quarter, I have to request a timesheet report from our national headquarters in Oakland, California. Typically I try to request that report at least a week before your filing deadline, though sometimes that process is slowed down by the failure of some staff (including myself on occasion) to get their timesheets in.

In April of this year, two things conspired to cause me to file both reports late. First, I mistakenly assumed that when the filing deadline fell on a weekend, the due date would be the first following workday. As you know, April 15 was a Saturday and, perhaps caught up with tax season deadlines, I just assumed I did not need to get the report in until that Monday.

I sent my request to our Oakland HQ on April 11 for the timesheet summary and then followed up on April 13 when I had not heard back from them. Unfortunately, in that April 13 message, I also told our HR department that the report wasn't due to the Commission until Monday (April 17) and asked could they please have the report to me by then. And that, of course, is exactly what happened. By the time I started getting the e-mails from OGEC on Saturday, April 15, that my filing was late and fines were

accruing, our HR staff was out of the office and I was not able to get he report before Monday even if I wanted to.

However, when I did indeed receive the report from Oakland on Monday, April 17, I immediately filed both reports with the Commission. Of course they were technically two days late at that point, resulting in a \$40 fine. And while most organizations and lobbying firms would laugh at a fine of that size, every dollar counts at our small nonprofit. Even though we are a branch of a large national organization, our state chapter budget is all our own and we receive little money from the national group.

Obviously we can and will pay the fine if we have to, but we would certainly prefer to put our members' dollars to better use than paying for an honest mistake that I made. And maybe I'm the only one who made the erroneous assumption that we had until Monday, April 17, to file the reports, but I'd be surprised if so. In any event, the lesson has been learned and I will not make that mistake again. However, I do hope you will accept my explanation for the late filing and decide you can forgive us the fines.

Please accept my apology for the mistake and do not hesitate to let me know if I can answer further questions you may have. Thank you for considering my request and I look forward to hearing your response.




