While my last day as a lobbyist was May 26th, 2016 (my last day at Eames Consulting), I understand my status was not terminated in the system until July 11, several days into Q3. I understand the missing form has been accumulating fines since that point. Kathy filed the form on my behalf today over the phone.

My last day at Eames Consulting as a lobbyist was May 26th, 2016. My email address at the company was terminated shortly thereafter. Therefore, I did not receive any notices of lateness or delinquency, or notice of fees owed to the Oregon Government Ethics Commission. As I mentioned, this was brought to my attention for the first time today (4/26/2017) by Kathy's phone call.

Re: Ken Glazer's Failure to File Lobbyist Expenditure Reports

Dear Mr. Golden:

I am writing to apologize sincerely for Ken Glazer's failure to file timely lobbyist expenditure reports for the fourth quarter of 2016 and first quarter of 2017 and to request mitigation of the penalties, which total \$5,500.00 imposed on him by the Oregon Government Ethics Commission ("OGEC"). Mr. Glazer has accrued these penalties because of his failure to terminate his lobbying registration and to file the required reports. We understand that after a report is more than 14 days late, the daily fine increases from \$10 per day to \$50 per day. Under firm policy, Mr. Glazer is responsible for these penalties even though they will be paid in the first instance by the firm. Mr. Glazer regrets his failure to comply with the OGEC's regulations and appreciates this opportunity to explain to the Commission the circumstances that led to this failure to comply with Oregon law.

Mr. Glazer was a partner at Sidley Austin LLP ("Sidley") from April 2013 to December 2016, when he retired from the practice of law after 31 years. He has been for his entire career an antitrust lawyer – for example, he was senior antitrust counsel for The Coca-Cola Company from 1996 through 2003, and from 2003 through 2006 he was the Deputy Director of the Federal Trade Commission's Bureau of Competition. At Sidley, he was a senior member of the firm's antitrust practice group. He was hired by Johnson & Johnson ("J&J") in 2014 in connection with a federal antitrust investigation relating to that Company's contact lens business. At around the same time, several state legislatures, including Oregon's, considered adopting legislation that would adversely affect J&J's contact lens business. J&J asked Mr. Glazer, as an antitrust expert, to speak with lawmakers in several states to explain why from an antitrust-law perspective the proposed legislation was unnecessary. As part of that project, Mr. Glazer met with Oregon legislators once in 2015 and once on or about February 3, 2016. Collectively those meetings lasted less than a day. Shortly after that second visit to Oregon, J&J changed its business strategy such that it would no longer be affected by the proposed legislation and therefore no longer needed Mr. Glazer's assistance on the state legislative front, in Oregon or any other state.

Mr. Glazer did not intend to lobby again in Oregon or other jurisdictions. And as mentioned, he retired from the firm, and the practice of law at the end of last year. He failed to file reports or formally terminate his status as an Oregon lobbyist because he was not aware that he needed to do anything formal to terminate his registration, as opposed to letting it lapse. He assumed he would never be involved in lobbying in Oregon ever again, and given that he is retired from the practice of law, that is a certainty.

I am the firm partner responsible for lobbying compliance. On May 5, 2017, I learned that the Commission had contacted a staff person at the firm on May 1, 2017, to make us aware of the needed reports and the outstanding penalties. On Friday, May 5, I contacted Mr. Glazer to verify the status of his filings and to determine whether he had done any lobbying in Oregon in the fourth quarter of 2016 and the first quarter of 2017. I also contacted the associate who worked on this project with Mr. Glazer and learned that no lobbying had been conducted during this period. The termination reports were filed on the following Monday, May 8, after I was able to speak to the associate in person and review firm records. To the best of my knowledge, no one at our firm, other than Mr. Glazer, has been a registered lobbyist in Oregon in the past, and because Sidley does not have an office in Oregon and lobbying is not a major practice for our firm, it seems unlikely that we will lobby in Oregon in the future.

As of December 31, 2016, Mr. Glazer became a retired partner of Sidley, and although he had access to his email account, he did not use it after leaving the firm. However, his email address remained associated with Mr. Glazer's account on OGEC's electronic filing system. Because Mr. Glazer was not using his Sidley email account, he did not receive either the original notifications that his lobbyist expenditure reports were available or any of the reminders from OGEC. We recognize that before his departure from Sidley, Mr. Glazer should have terminated his active status as a lobbyist prior to his retirement from the practice of law.

Upon learning of Mr. Glazer's failure to file these reports, Sidley, on Mr. Glazer's behalf, promptly rectified Mr. Glazer's oversights and filed the missing expenditure reports. Mr. Glazer has never incurred any reportable expenditures in Oregon, nor does he plan to engage in any lobbying in Oregon in the future. Effective May 8, 2017, Mr. Glazer has terminated his status as an active lobbyist with the state of Oregon, but because Mr. Glazer was "active" for a portion of the second quarter of 2017, Sidley understands that an expenditure report for this quarter will be due between July 1 – 15, 2017. I will personally make sure that this report is filed on time.

On behalf of Mr. Glazer, and based on the circumstances described above, I would like to request that OGEC consider waiving in whole or in part the penalties that Mr. Glazer has accrued.
