This correspondence is in reference to the letter you sent to me that was dated July 25. First and foremost, as I will explain, I only became aware of that letter yesterday.

While I don't want to launch into a diatribe of what will sound like "excuses," I need to simply tell you what happened. I live on a rural mail route and we are constantly beset by problems with an ever-changing cast of carriers. I am not exaggerating when I say that at least once a week, frequently more often, I get mail addressed to some neighbor near or far. I can only reasonably assume they get my mail periodically as well.

Your letter says I was sent a notification regarding my registration being terminated on Jan. 5. I can state unequivocally that I never received that notification. If it came electronically it would have gone to my Realtors email address, which they did not forward to me. If it was sent via post it never arrived in my mail box.

I just discovered the July 25 letter yesterday while doing a last check of a stack of junk mail I was about to recycle. It was squashed inside of a Fred Meyer advertising circular, another favorite trick of our various rural carriers. So, despite the apparent lateness of this missive, I am actually responding within 24 hours of finding out about this.

As to the particulars of the situation, I was on a six-month contract with the Oregon Association of Realtors that was abruptly terminated on Jan. 4. We had talked about the possibility of me helping their lobbying efforts but that was never, to my understanding, a sure thing. Given that I left the Realtors' employ over a month before the session started, it never occurred to me that I would need to file a report for what, the one day of 2017 that I was apparently on their roster? I did not even set foot in the capitol building one time during the '17 session.

I was unemployed from Jan. 4 until about two weeks ago. I barely have \$44 to my name quite frankly, let alone \$4,400. That's not going to happen. As soon as I post this letter I will go online and see if I can file the report electronically. If not, I would appreciate your help in settling this matter. Please accept my apologies for not completing the required ethics information. I understand there are substantial penalties applied. I was not aware of such penalties or the responsibility of completing the document each year.

The email that information was sent is no longer valid as I have lost access to it. I understand that there was a phone call to my correct phone number and the timing of that communication was extremely unfortunate. Within the weeks surrounding the communication, I gained a new great niece and lost my grandmother. My family lost one generation and started another. As I'm sure you can can imagine this took a toll emotionally, mentally and physically. In addition, the amount of time spent focused on these events and my family clearly left my capacity unable to complete the form. I don't recall receiving postal service mail with the form or the City staff mentioning this detail. It is out of character to not complete required documentation and I feel that quality is demonstrated in my community efforts.

In the last three months, I started a graduate program and escalated my board service to President of an area on profit. My life has been dedicated to service to others and the community. I had hoped to expand my reach to Jefferson and feel as though I have failed to meet the responsibility within the scope of commissioner by not understanding the ethics reporting requirement. I ask that you please waive the penalties assigned to me as they will cause a severe detriment and impact my future in a negative way. In fact, my resources are limited and yhe time it would take to repay I have worked hard to give back and get where I am. 
