





#### 3. STIPULATED FACTS:

A. In his position as board member of Lakeside Fire District, John Miller signed two documents under the advisement of the fire district's legal counsel. One document, signed along with a majority of other board members on 4/10/15, authorized fire district legal counsel to represent them in any matters involving the Commission. Mr. Miller and other board members also signed individual notices of attorney representation on 5/20/15, which were sent to the Commission to provide notice that fire district legal counsel represented them against complaints in preliminary review and investigation.

- B. John Miller, in acting as a board member of the Lakeside Fire District, was met with a conflict of interest in signing the documents described in paragraph (A), which authorized fire district legal counsel to represent him. Mr. Miller did not publicly disclose the nature of his conflict of interest prior to signing these documents.
- C. At the expense of Lakeside Fire District, Mr. Miller was represented by the fire district's legal counsel during preliminary review in Government Ethics Commission Case No. 15-208XDT.
- D. ORS 244.040(1) prohibits any public official from using their official position or office to obtain financial gain for the public official, other than official salary, honoraria or reimbursement of expenses.
- E. ORS 244.120 requires public officials to disclose conflicts of interest prior to taking official action, which could or would result in financial impact to the public official, a relative of the public official or a business with which the public official or a relative is associated.
- F. The actions described in paragraphs (A) and (C) above constituted a violation of ORS 244.040(1).
- G. The actions described in paragraphs (A) and (B) above constituted a violation of ORS 244.120(2).
- H. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$5,000 as a result of these violations.
- ORS 244.360 authorizes the Commission to order Mr. Miller to pay a monetary forfeiture of twice the amount of any financial gain Mr. Miller realized as a result of these violations.

J. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 244.040(1) and ORS 244.120(2).

- C. Ms. Castillo determined amounts and distributed Christmas gifts in 2014, 2015, and 2016 to the City's Planning Commissioners, City Councilors, and City staff, including herself.
- D. ORS 244.120 requires public officials to disclose conflicts of interest prior to taking official action, which could or would result in financial impact to the public official. Ms. Castillo did not disclose a conflict of interest prior to taking the actions in paragraphs (A), (B), and (C) above.
- E. The actions described in paragraphs (A), (B), and (C) constitute three violations of ORS 244.120(1)(c).
- F. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$5,000 for each violation.
- H. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 244.120(1)(c).

- 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Joseph VonDoloski.
- JURISDICTION: At all material times, Joseph VonDoloski was the Executive Director for the Logos Public Charter School. Joseph VonDoloski was a public official subject to the jurisdiction of the Commission pursuant to ORS Chapter 244.

### 3. <u>STIPULATED FACTS</u>:

- A. Western Collegiate Consulting, LLP, (WCC) is a business owned by Joseph VonDoloski. WCC is a professional employer organization (PEO) that leases employees to public charter schools.
- B. On or before 2/15/17 Joseph VonDoloski selected a retired banker he knew, outside of any formal Board process or public contracting process, to act as the LOGOS financial consultant in creating a cost analysis that showed the savings LOGOS could realize if they contracted with a professional employer organization to supply teachers and other personnel to LOGOS.
- C. In early 2017, Respondent, in his capacity as executive director, directed the LOGOS HR/Business Manager, to use LOGOS time, financial data,

email, and other public resources, to collaborate on the cost analysis described above in paragraph B.

- D. In early 2017, Respondent, in his capacity as executive director, was contacting other public charter schools about outsourcing employee costs to a professional employer organization to save money. For example, on 2/15/17, he wrote in a LOGOS email that he was "following up with all my contacts regarding becoming a PEO".
- E. On 5/8/17, the Respondent, in his capacity as executive director, provided the LOGOS Board with a 5 year cash flow forecast, a narrative analysis of three options to save money, and his own recommendation to the Board that LOGOS issue a Request for Proposal (RFP) to contract with a professional employer organization to avoid pension costs. In support of his recommendation, Respondent supplied the Board with a forecast of projected savings over the next 5 years if LOGOS used a professional employer organization. These projected savings included salaries and benefits allocated to Respondent and the LOGOS HR/Business Manager, who would be employed by Western Collegiate Consulting rather than LOGOS if the Respondent's business received the contract with LOGOS.
- F. Respondent, in his capacity as executive director, attempted to involve himself in the potential LOGOS Request for Proposal (RFP) process to obtain a professional employer organization, evidenced by LOGOS email he sent on 5/2/17, which suggested to a Board member the makeup of the RFP committee and timeline, and an email he sent on 5/4/17 to the LOGOS attorney concerning LOGOS's advertising of the RFP.
- G. Respondent used LOGOS time and resources to advertise his private business to other charter schools and solicit the schools as clients on the following occasions: 5/1/17, 5/9/17, 5/10/17, 5/11/17, and 5/12/17.

- H. Respondent used LOGOS time and resources to obtain his private business's domain name, email address, webpage, logo design and business cards for himself and the LOGOS HR/Business Manager over several days between 4/18/17 and 5/2/17.
- I. Respondent used LOGOS time and resources on 5/12/17 to obtain information about how his private business could avoid a financial detriment by avoiding labor requirements and prevailing wage laws.
- J. Respondent used LOGOS time and resources on 6/28/17 to obtain insurance services for his private business.
- K. Respondent used the LOGOS Employee Handbook and other LOGOS resources when soliciting workers compensation coverage for his private business on 5/23/17.
- L. Respondent used LOGOS non-public information, time, and resources to prepare and submit a response to the LOGOS Request for Proposal on 6/16/17 on behalf of his private business.
- M. ORS 244.040(1) prohibits any public official from using their official position or office to obtain financial gain for the public official or a business with which the official is associated, other than official salary, honoraria or reimbursement of expenses.
- N. Each of the actions described in paragraphs (B) through (L) above constituted distinct violations of ORS 244.040(1).
- O. ORS 244.120 requires public officials to disclose conflicts of interest prior to taking official action, which could or would result in financial impact to the

public official, a relative of the public official, or a business with which the public official or a relative is associated.

- P. Joseph VonDoloski did not disclose a conflict of interest prior to taking the actions described in paragraphs (B) through (L).
- Q. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$110,000 as a result of these violations.
- R. ORS 244.360 authorizes the Commission to order Joseph VonDoloski to pay a monetary forfeiture due to the financial gain Joseph VonDoloski realized as a result of these violations. The Commission is not seeking a monetary forfeiture.

- F. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 192.660(2).

### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

- A. On June 29, 2018, the Commission acted to find violation, bring the investigative phase to a close and move to a negotiated settlement or a contested case hearing. The June 29, 2018 action was a preliminary finding of violations of Oregon Government Ethics law, as a prelude to a stipulated settlement or a contested case hearing, and not a final conclusion regarding a violation of the executive session provisions of Oregon Public Meetings law by Georgia Patterson.
- B. Georgia Patterson will receive a letter of education, as authorized by ORS 244.350, in order to settle and compromise this matter.
- C. The Commission releases, settles and compromises any and all claims, which have been or could be asserted against Georgia Patterson within the scope of the above-referenced proceedings.
- D. Georgia Patterson will initiate no claims, litigation or other action against the
   Commission as a result of these proceedings.

### 5. <u>REVIEW BY COUNSEL</u>:

All of the parties hereto acknowledge that this agreement has been entered into by their own free will and with full understanding of the contents herein. Each of the parties further acknowledges that each has had the opportunity to seek the advice of counsel in comparing and reviewing this agreement.

### 6. <u>EFFECT</u>:

This agreement is subject to the final approval of the Commission. Once approved, this agreement shall be the final disposition of the matter and shall be binding upon all parties.

By signing this agreement, Georgia Patterson agrees to waive her right to a contested case hearing as provided in ORS Chapter 183 and ORS 244.370. This order shall be the final order and all information in the Commission files on this matter shall become part of the record.

By signing this agreement, Georgia Patterson agrees to waive her right to obtain judicial review of this order as provided in ORS 183.482.

- 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Joe Phippen.
- 2. <u>JURISDICTION</u>: At all material times, Joe Phippen was a member of the City Council for the City of Prairie City. As the governing body of a public body, the members of the city council are subject to the executive session provisions of Oregon Public meetings law as set forth in ORS 192.660 and ORS 192.685.

### 3. STIPULATED FACTS:

- A. Joe Phippen participated in an executive session held by the City of Prairie City Council (council) on 8/29/2017. The purpose of the executive session was to discuss the salary of a city employee. The reason cited for the executive session was ORS 192.660(2)(a) and ORS 192.660(3).
- B. ORS 192.660(2)(a) permits the governing body of a public body to hold an executive session to consider the employment of a public officer, employee, staff member or individual agent.

- C. 192.660(3) which allows for labor negotiations to be conducted in executive session only if negotiators for both sides request that negotiations be conducted in executive session.
- D. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. The purpose of the 8/9/17 executive session was to discuss the salary of one of the City's employees with that employee. The topic of salary negotiation in executive session is explicitly prohibited by OAR 199-040-0020. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. ORS 192.660(3) was also cited as a lawful basis for the executive session, but only topics permitted by ORS 192.660(2) may be discussed in executive session.
- E. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$1000 as a result of this violation.
- F. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find a violation of ORS 192.660(2).

### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

This letter of advice is provided in response to your request received on July 8, 2018, which presented a question regarding the application of how Oregon Government Ethics law may apply to the participation of public officials in a fact-finding mission, during which food and beverage will be provided at the 2018 Oregon Coastal Caucus Economic Summit.

This analysis and advice is being offered under the authority provided in ORS 244.284 as guidance on how the current provisions of Oregon Government Ethics law may apply to the specific circumstances you have presented.

On August 22 and 23, 2018, the Oregon Legislative Coastal Caucus is holding its 7<sup>th</sup> Annual Oregon Coastal Caucus Economic Summit (OCCES). The theme of the 2018 OCCES event is "Student Success: Challenges and Opportunities in Education" and "The Sequestration of Carbon: A Collaborative Approach to Cap, Investment and Green Energy Job Growth" to discuss economic, environmental quality-of-life and educational policy issues that affect the residents of the region.

During this event at the Chinook Winds Casino, the Confederated Tribes of the Siletz will provide and pay for meals. In the request you have asked what restrictions or requirements Oregon Government Ethics law may impose on public officials who may wish to participate in this event.

Invited participants will include legislators as well as a variety of others that represent economic development and education from various state and local jurisdictions. The purpose of this event is to educate and inform state and local government officials as well as regional stakeholders regarding matters affecting the current economic and education conditions facing Oregon's rural and coastal communities. Those who participate will be provided food and beverage expenses.

Under most circumstances when a public official is offered food and beverage at no cost to the public official it would be a gift as defined in ORS 244.020(7)(a). ORS 244.020(7)(b) however, identifies occasions wherein public officials may accept paid expenses for food and beverage.

The exception relevant to your inquiry is described in ORS 244.020(7)(b)(E) which allows the acceptance of payment of admission provided to or the cost of food or beverage consumed by a public official, or a member of the household or staff of the public official when accompanying the public official, at a reception, meal or meeting held by an organization when the public official represents state government as defined in ORS 171.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 171.117.

Based on the information provided, ORS 244.020(7)(b)(E) would allow public officials, relative, member of the household or staff of the public official when accompanying the public official, to accept the payment of food and beverage from the Confederated Tribes of the Siletz.







Dear Ms. Griggs:

This letter of advice is provided in response to your request received on July 17, 2018 which presented a question regarding the application of Oregon Government Ethics law regarding statutory conflicts of interest. This analysis and advice is being offered under the authority provided in ORS 244.284 as guidance on how the current provisions of Oregon Government Ethics law may apply to the specific circumstances you have presented.

You indicate in your request for guidance that you are currently serving on the City of Salem Planning Commission (Commission). Additional information provided indicates that your spouse, Jim Griggs was a partner in the Saalfeld Griggs business law firm (Firm). One of the areas of the Firm's practice is real estate & land use. The Real Estate & Land Use Group provides legal guidance regarding urban and rural land use and development matters. The Firm represents individuals and businesses (clients) who may come before the City of Salem Planning Commission.

As of December 31, 2017, your spouse retired from the Firm and subsequently sold his business shares to the Firm. Your spouse receives a salary continuation as part of a contract with the Firm.

The question you asked is, now that your spouse is no longer a partner in the Firm, would you still be met with statutory conflicts of interest if the Firm represented clients before the Commission?

Oregon Government Ethics law defines two types of statutory conflicts of interest, "actual" [ORS 244.020(1)] and "potential" [ORS 244.020(13)]. The difference between an actual conflict of interest and a potential conflict of interest is determined by the personal financial effect of the words "would" and "could".

An actual conflict of interest occurs when a public official participates in an official action that would have a certain financial impact on that public official, a relative, or any business with which the public official or their relative is associated. A potential conflict occurs when a public official takes action that could possibly have a financial impact on the public official, a relative, or any business with which the public official or their relative is associated.

On each occasion you are met with a statutory conflict of interest, you must determine if the matter gives rise to an "actual" or a "potential" conflict of interest, you will then be required publicly state the nature of the conflict. If met with an actual conflict of interest, prior to taking any action, publicly disclose the nature of the conflict after which you would be required to refrain from any further participation or from voting on the issue. If met with a potential conflict of interest, you would need to publicly disclose the nature of the conflict prior to taking any official actions on the matter. [ORS 244.120(2)(a) & (b)(A)]

As a Planning Commissioner, you are required to file an Annual Verified Statement of Economic Interest (SEI). [ORS 244.050(1)(k)].

ORS 244.020(3)(d) states that for public officials required to file a statement of economic interest, any business listed as a source of income by the public official is business with which the public official is associated. Public officials must disclose on their SEIs the sources of income that comprise 10% or more of their household's annual income. If the Firm provides 10% or more of your household's annual income, it is a business with which you are associated. Therefore, you would be met with a conflict of interest when taking official action as a Planning Commissioner that "would" or "could" financially impact the Firm, even if it does not financially impact you or your spouse.

A conflict is presented if your official action would or could financially impact the Firm. As such, while acting in your official capacity as a Commissioner, there may be circumstances in which matters will come before you that you will need to determine if the action, decision or recommendation you take "would" or "could" be

to the private pecuniary benefit or detriment of the Firm, a "business with which you are associated".

As to the Firm representing a client before the Planning Commission, and if the client is not a person or business with which you or your relative are associated, it would not appear that you would be met with a conflict of interest when taking official actions on the client's matter. Because the Firm remains a business with which you and your relative are associated, if the Firm itself has a matter before the Planning Commission, you would be met with a conflict of interest and would have to comply with the provisions in ORS 244.120(2) as described above.

It is important to note that this analysis is based on the assumption that any official actions which you might have the opportunity to perform as a member of the Salem Planning Commission would not result in either a pecuniary benefit or detriment to Saalfeld Griggs, which is a business with which you are associated. If an official action would or could result in a private pecuniary benefit or detriment for Saalfeld Griggs, then you would be faced with a conflict of interest.
