

To Whom It May Concern,

I am writing to address and provide explanation for outstanding delinquent reporting fees and penalties that I was made aware of per a telephone call with Kathy Baier on Wednesday, November 14, 2018.

The first delinquent reporting incident on my record is from report due for the fourth quarter of 2016. From the middle of December 2016 until the end of January 2017, I was away from my job on leave per the Family Medical Leave Act (FMLA)/Oregon Family Leave Act (OFLA). My extended absence put me out of communication with my employer, including email and phone. The leave also otherwise made me incapable of filing the report. Until my conversation with Kathy on November 14th, I was under the impression that I had made payment for the associated late penalties upon my return to work in late January/early February 2017. After my conversation with Kathy, I concede that I can find no record that such payment was received by OGEC.

The second delinquent reporting incident centers around my departure from my employment at the Oregon Health Authority (OHA). I left OHA on November 24, 2017 and transitioned to new employment that did not require registration as a lobbyist. I was unaware that I had any responsibilities to "close out" my OGEC account when this transition occurred and since I no longer had an active email account with the State of Oregon, any reminders or notices sent to that account after November 24, 2017 would not have been known to me.

In addition to considering the circumstances surrounding my two late reporting incidences, I respectfully request that OGEC consider the nature of my employment and the reporting I made during my time as a registered lobbyist. As an employee of the State of Oregon, I was never authorized to make any expenditures or receive any reimbursement that would be reportable under the applicable OGEC rules. Every report I attested to, including those that were submitted late, accurately and honestly reported no expenses, contributions, or other financial exchanges. My attestations to this effect were reflections of the guidelines and restrictions that governed my employment with the OHA.

I thank you for taking this letter into consideration. I would be happy to answer any questions the Commission may have.

- PURPOSE: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Linda Hald.
- 2. <u>JURISDICTION</u>: At all material times, Linda Hald was a Community Justice Department Office Manager for Columbia County. Linda Hald was a public official subject to the jurisdiction of the Commission pursuant to ORS Chapter 244.

#### STIPULATED FACTS:

- A. Linda Hald retired from her position with Columbia County on 6/30/15, after 30 years. As Office Manager of the Community Justice Department, Ms. Hald received payments from clients for services such as electronic monitoring, drug tests, and supervision, provided receipts to the clients, and reconciled and remitted those revenues to the treasury on a monthly basis. The County retained a forensic accounting firm to conduct an investigation of the Community Justice Department after a large increase in cash receipts was noticed following Ms. Hald's retirement. The auditors concluded that Ms. Hald had been diverting the County's cash receipts to herself for several years and covering up by altering Community Justice Department records. The auditors found evidence of the discrepancies as far back as 1999, but the Commission only has authority to investigate conduct that occurred four years prior to the opening of this case on 12/16/16.
- B. As a result of the forensic audit and the state police investigation, Ms. Hald became the subject of a criminal investigation. She was indicted by a Columbia County



grand jury on 10/20/16 on multiple charges of theft, tampering with public records, and official misconduct that occurred between 2010 and Ms. Hald's retirement. On 3/7/18, Linda Hald pled guilty to one charge of aggravated theft and all other charges were dropped. On 7/10/18, Ms. Hald was sentenced to incarceration for a term of 30 months and post-prison supervision for two years. She was also ordered by the court to pay fines and restitution in the amount of \$95,000 to Columbia County.

- C. ORS 244.040(1) prohibits any public official from using their official position or office to obtain financial gain for the public official, other than official salary, honoraria or reimbursement of expenses.
- D. The actions described in paragraph (A) above constituted violations of ORS 244.040(1).
- E. ORS 244.120 requires public officials to disclose conflicts of interest prior to taking official action, which could or would result in financial impact to the public official, a relative of the public official or a business with which the public official or a relative is associated.
- F. Linda Hald did not disclose a conflict of interest prior to taking the actions described in paragraph (A).
- G. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$5,000 for each of these violations.
- H. ORS 244.360 authorizes the Commission to order respondent to pay a monetary forfeiture in the amount of twice the amount of financial gain realized as a result of these violations.
- I. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 244.040(1) and ORS 244.120(1)(c).

#### 4. <u>TERMS OF SETTLEMENT</u>:

The parties agree as follows:

- A. On 1/27/17, the Commission considered information in the preliminary review phase and acted to find cause to initiate an investigation of these matters. The investigation was suspended due to the ongoing criminal matters, which concluded with the sentencing on 7/10/18. Linda Hald, through her attorney, has indicated that she wishes to conclude this matter by agreeing to the terms and conditions in this order without completing the investigative phase.
- B. Linda Hald will pay a civil penalty, as authorized by ORS 244.350, in the amount of \$3,000 in order to settle and compromise this matter.
- C. Linda Hald will not pay a forfeiture, as authorized by ORS 244.360, because she is under court order to pay fines and restitution to the victim.
- D. The civil penalty in item B above will be paid at a monthly rate of \$300 for a period of ten months. The payments will be due on or before the 5th day of each month with the first payment being due on the 5th day of the month following the date this order is fully executed. All payments will be interest free. If a payment becomes 10 days or more delinquent, the entire balance will be assigned to the Oregon Department of Revenue for collection.

- C. 192.660(3) allows for labor negotiations to be conducted in executive session only if negotiators for both sides request that negotiations be conducted in executive session.
- D. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. The purpose of the 8/9/17 executive session was to discuss the salary of one of the City's employees with that employee. The topic of salary negotiation in executive session is explicitly prohibited by OAR 199-040-0020. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. ORS 192.660(3) was also cited as a lawful basis for the executive session, but only topics permitted by ORS 192.660(2) may be discussed in executive session.
- E. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$1000 as a result of this violation.

- C. 192.660(3) allows for labor negotiations to be conducted in executive session only if negotiators for both sides request that negotiations be conducted in executive session.
- D. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. The purpose of the 8/9/17 executive session was to discuss the salary of one of the City's employees with that employee. The topic of salary negotiation in executive session is explicitly prohibited by OAR 199-040-0020. ORS 192.660(2)(a) permits the topic of one's initial employment with the public body to be discussed in executive session, but not periodic salary discussions with current employees. ORS 192.660(3) was also cited as a lawful basis for the executive session, but only topics permitted by ORS 192.660(2) may be discussed in executive session.
- E. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$1000 as a result of this violation.
- F. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find a violation of ORS 192.660(2).

#### 4. <u>TERMS OF SETTLEMENT</u>:

The parties agree as follows:

- A. On June 29, 2018, the Commission acted to find violation, bring the investigative phase to a close and move to a negotiated settlement or a contested case hearing. The June 29, 2018 action was a preliminary finding of violations of Oregon Government Ethics law, as a prelude to a stipulated settlement or a contested case hearing, and not a final conclusion regarding a violation of the executive session provisions of Oregon Public Meetings law by Frank Primozic.
- B. Frank Primozic will receive a letter of education, as authorized by ORS 244.350, in order to settle and compromise this matter.
- C. The Commission releases, settles and compromises any and all claims, which have been or could be asserted against Frank Primozic within the scope of the above-referenced proceedings.
- D. Frank Primozic will initiate no claims, litigation or other action against the Commission as a result of these proceedings.

#### 5. REVIEW BY COUNSEL:

All of the parties hereto acknowledge that this agreement has been entered into by their own free will and with full understanding of the contents herein. Each of the parties further acknowledges that each has had the opportunity to seek the advice of counsel in comparing and reviewing this agreement.

#### 6. **EFFECT**:

This agreement is subject to the final approval of the Commission. Once approved, this agreement shall be the final disposition of the matter and shall be binding upon all parties.

By signing this agreement, Frank Primozic agrees to waive his right to a contested case hearing as provided in ORS Chapter 183 and ORS 244.370. This order shall be the final order and all information in the Commission files on this matter shall become part of the record.

By signing this agreement, Frank Primozic agrees to waive his right to obtain judicial review of this order as provided in ORS 183.482.

- 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Travis Ward.
- 2. <u>JURISDICTION</u>: At all material times, Travis Ward was a network administrator for Yamhill County (County). Mr. Ward was a public official subject to the jurisdiction of the Commission pursuant to ORS Chapter 244.

#### 3. STIPULATED FACTS:

- A. Without authorization, Travis Ward installed cryptocurrency mining software on eight County computers and used those computers and the County's electricity to engage in cryptocurrency mining. Before discovery, Mr. Ward engaged in cryptocurrency mining on one computer for approximately eleven weeks and on the remaining seven computers for one week.
- B. The cryptocurrency mining described in paragraph A did not actually result in a financial benefit for Mr. Ward; however, it did permit him to avoid the personal financial detriment of having to use his own computers and personally pay for the associated electricity required to engage in such cryptocurrency mining.

- C. ORS 244.040(1) prohibits any public official from using their official position or office to obtain financial gain for the public official, other than official salary, honoraria or reimbursement of expenses, or to avoid financial detriment for the public official.
- D. The actions described in paragraph A constitute a violation of ORS 244.040(1).
- E. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$5,000 as a result of these violations.
- F. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 244.040(1).
- G. Travis Ward disagrees with the above conclusions and contends that the results of the investigation, if submitted through exhibits and testimony in a hearing, would not establish a preponderance of evidence in support of any violations of ORS 244.040(1). In order to conclude this matter, however, Mr. Ward agrees to the terms and conditions in this Stipulated Final Order.

#### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

A. On May 11, 2018, the Commission considered information in the preliminary review phase and acted to find cause to initiate an investigation of this matter. Travis Ward has indicated that he wishes to conclude this matter by agreeing to the terms and conditions in this order without completing the investigative phase.

RELEVANT STATUTES: The following Oregon Revised Statutes and Administrative

Rules are applicable to the issues addressed herein:

244.020(15) "Public official" means the First Partner and any person who, when an alleged violation of this chapter occurs, is serving the State of Oregon or any of its political subdivisions or any other public body as defined in ORS 174.109 as an elected official, appointed official, employee or agent, irrespective of whether the person is compensated for the services.

## 244.040 Prohibited use of official position or office; exceptions; other prohibited actions.

(1) Except as provided in subsection (2) of this section, a public official may not use or attempt to use official position or office to obtain financial gain or avoidance of financial detriment for the public official, a relative or member of the household of the public official, or any business with which the public official or a relative or member of the household of the public official is associated, if the financial gain or avoidance of financial detriment would not otherwise be available but for the public official's holding of the official position or office.

(2) Subsection (1) of this section does not apply to:

(a) Any part of an official compensation package as determined by the public body that the public official serves.

## OAR 199-005-0035 Guidelines for compliance with ORS 244.020(6), 244.025, 244.040, 244.042 and 244-047

(3) An "official compensation package" means the wages and other benefits provided to the public official. To be part of the public official's "official compensation package", the wages and benefits must have been specifically approved by the public body in a formal manner, such as through a union contract, an employment contract, or other adopted personnel policies that apply generally to employees or other public officials. "Official compensation package" also includes the direct payment of a public official's expenses by the public body, in accordance with the public body's policies.

INVESTIGATION: The Oregon Government Ethics Commission (Commission) initiated a preliminary review based on information in a March 20, 2017 signed complaint from James Craver, alleging that John Phelan may have violated Oregon Government Ethics law by using his assigned County vehicle for personal business. (#PR1). The Commission found cause to investigate on June 2, 2017 after considering the information developed in the preliminary review. The focus of the investigation was to determine if there is sufficient evidence to indicate that John Phelan may have violated the use of office provisions of ORS 244.040(1). John Phelan and James Craver were both notified of the Commission actions in this matter and invited to provide any information which would assist the Commission in conducting this investigation.

The Complaint alleged that on March 10, 2017, John Phelan used his assigned County vehicle for a personal purpose by driving it to the Morrow Crane Building in Salem to attend an Oregon Government Ethics Commission meeting in which the Commission was considering an ethics complaint made against him. Attached to the Complaint were photographs, allegedly taken on March 10, 2017, of Mr. Phelan's assigned County vehicle parked in the parking lot of the Morrow Crane Building. (#PR1).

In his response, Mr. Phelan acknowledged that he drove his assigned County vehicle to the Commission meeting in Salem on March 10, 2017. He provided Commission staff with a copy of the explanation he had previously given to the County Administration. In that explanation, he claimed that by appearing at the ethics meeting he was defending Yamhill County's administrative actions in that prior matter. Mr. Phelan also asserted that he conducted County business on the way back from Salem to McMinnville. (#PR2).

In moving this matter to investigation, the Commission found that further investigation was needed to determine the facts surrounding Mr. Phelan's claim that he travelled to Salem for a county purpose, such as whether a meeting occurred, and if so, when the appointment was made, and to review Yamhill County policies concerning use of assigned county vehicles to determine whether Mr. Phelan's personal use was permissible.

With regard to the County business conducted on March 10, 2017, Mr. Phelan reported to his superiors at the County as follows [quotations provided as written, without corrections or notations]:

My reason for attending this hearing on March 10<sup>th</sup> was to testify as to the second charge that there was wrong doing in Safe Conduct award of Yamhill County drug testing agreement (contract). \* \* \* I have never accepted that this ethics violation was directed toward me directly but to an oversight of County administration and myself at the time the contract was developed and implemented. With that being said I feel I was attending and defending Yamhill County's administrative actions.

Knowing full well that this could be challenged. I had to meet with Mark Gehring at 3600 Wallace Road Salem Oregon address in regards to an agreement that Public Works was trying to develop where he was going to donate and antique blade too PW to place on display in front of our new office/shop building. Russ Heath (Fleet Manager) and I had meet with Mr. Gehring two weeks before and were not able to agree on the value and the process of obtaining the piece of equipment. I'm attaching a photo of the equipment in discussion and the time and DATE stamped of March 10<sup>th</sup> at 11:23. (#PR2).

Mr. Phelan's explanation further justified his use of the County vehicle on that date by explaining that because of recent flooding he also went to examine some County roads that were closed:

From that meeting I went to Wheatland Ferry and I'm also attaching a photo taking there of the road being closed time stamped March 10<sup>th</sup> at 11:39. From there I went to Grand Island because of road closer and attaching photo time and date stamped March 10<sup>th</sup> at 11:53. From there I went to Mallard lane and again photo date and time March 10<sup>th</sup> 12:14. (#PR2).

Commission staff spoke with Mr. Phelan, who reiterated that he stopped at the Gehring farm to look at the equipment because they were still trying to work out a deal for it. When we spoke he called it a grader, but in his original response it was referred to as a blade. He also said that it had been raining heavily during the days before the Commission meeting and that a number of roads were flooded and closed. He stopped on the way back to McMinnville to take photos of the grader and of some of the flooded roads. (#INV1).

On November 20, 2018, Commission staff spoke by telephone with Russ Heath, Yamhill County Shop/Fleet Manager. Mr. Heath did not recall whether he knew about Mr. Phelan's March 10, 2017 visit to the Gehring farm, but he did confirm that he and Mr. Phelan had previously looked at the grader and had spoken with Mark Gehring on a couple of different occasions, and he had even drawn up an agreement at some point. Mr. Heath's last reported contact with Mr. Gehring was an e-mail sent on March 3, 2017 identifying what he had found as fair market value of the grader. He was not able to locate any e-mails after that date and he doesn't recall any further conversation about the matter with Mr. Phelan. (#INV2).

Commission staff spoke with Mark Gehring by telephone on November 27, 2018. Mr. Gehring does not specifically know or remember John Phelan, but he does recall meeting two gentlemen from the County who wanted to buy or have him donate the old grader. Mr. Gehring remembers having a second conversation with one or both gentlemen about valuing the grader for tax donation purposes, but says that nothing ever happened after that. At this point, he does not recall whether anyone came to the farm on March 10, 2017 to photograph the equipment. (#INV3).

#### COUNTY POLICY

Commission staff reviewed the Yamhill County policy regarding assigned county vehicles. The Assigned County Vehicles policy was issued by the Yamhill County Board of Commissioners by Board Order 02-111 and became effective on May 1, 2002. (#INV4). The policy provides as follows:

- 1. For purposes of this policy, the following definitions apply.
  - (a) An "assigned vehicle" means a vehicle owned or controlled by Yamhill County and assigned to an employee for regular use to be driven to and from work. If required under IRS rules, income will be imputed to the employee or official for use of an assigned vehicle.

4. Any employee authorized to use an assigned vehicle must keep a record of the number of emergency call-outs or other use of the assigned vehicle apart from trips from home to work or work to home. The record is considered a public record which must be disclosed upon request. The record must be kept for at least two years. The record must provide at least the following information:

Reason for use of vehicle (other than home-to-work)

6. Under no circumstances shall an employee use an assigned vehicle for any non-county business.

Mr. Phelan acknowledged driving the County vehicle assigned to him to attend the Commission meeting on March 10, 2017. When Commission staff spoke with Mr. Phelan, he indicated that he believed the County policy had changed at some point to allow incidental personal use. (#INV1).

- To follow up on whether County policy had been amended, Commission staff spoke with Laura Tschabold, County Administrator for Yamhill County. Ms. Tschabold said that after speaking with Mr. Phelan about our investigation, her staff searched through the Board Orders. She said she recalls there was discussion about amending the County Policy, but she doesn't believe the policy was ever formally modified. In a follow-up e-mail, Ms.
- Tschabold reported that they have been unable to find any documents or records showing 33

the County policy was amended. Ms. Tschabold did comment, however, that "it is past practice for the county to allow these types of incidental personal stops on the way to and from an employee's residence for an occasional errand or other infrequent personal stops enroute to a work related purpose." (#INV5).

Commission staff asked Ms. Tschabold whether the County had the vehicle use record for Mr. Phelan's use of the assigned vehicle on March 10, 2017, as required by subsection (4) of the County policy. Ms. Tschabold reported that the "practice of record keeping had not been followed by employees with assigned vehicles." She said that she has had new employees follow the procedure and also indicated that the County was currently in the process of revising and re-adopting this policy. (#INV5).

Commission staff asked Russ Heath about this vehicle use policy, since he is the County fleet manager. Mr. Heath said that the policy allows an employee with an assigned vehicle to use the vehicle for incidental personal business, i.e., to stop at the store on the way to or from work, but employees were not supposed to use assigned County vehicles to drive out of town on personal business. (#INV2).

#### REIMBURSEMENT TO THE COUNTY

On March 10, 2017, John Phelan did make a partial reimbursement to the County for his personal use of the County vehicle. In his explanation to the County administration, he reported, "I went to Public Works office and meet with Catherine Lindberg around 12:45 on March 10<sup>th</sup> and gave her Four Dollars for the milage I drove to attend the Ethic review hearing (roughly one mile) also attached." Mr. Phelan provided a copy of a receipt, dated 3/10/2017, showing he paid \$4.00 to the Public Works office for the mileage (estimated on the receipt to be approximately 1 mile) driven to attend the Commission meeting. (#PR2). When Commission staff spoke with Mr. Phelan, he did not recall why this distance or this amount was selected. (#INV1). When Commission staff spoke with Yamhill County Administrator Laura Tschabold, she suggested that the amount of this reimbursement might have been based on the County's standard employee mileage reimbursement rate of 50 cents per mile. (#INV5).

1 Using Google Maps, Commission staff determined that the driving distance between the

- 2 Yamhill County Public Works building in McMinnville and the Morrow Crane building in
- 3 Salem is 29.4 miles, making the round-trip travel distance 58.8 miles. Commission staff
- 4 also determined that the driving distance between the Gehring farm in West Salem and
- the Morrow Crane building is 6.2 miles, making the round-trip travel distance 12.4 miles.
- 6 (#INV6).

- 8 CONCLUSIONS: John Phelan, Director of Yamhill County's Public Works Department,
- 9 is a public official as defined in ORS 244.020(15). At all times relevant to this investigation,
- 10 Mr. Phelan was subject to Oregon Government Ethics law.

- ORS 244.040(1) prohibits a public official from using or attempting to use their official
- position to obtain a financial benefit or avoid a financial detriment for themselves, a
- relative or household member, or a business with which they or a relative or household
- member are associated, if the financial benefit would not otherwise be available to them
- but for holding their official position. This prohibition does not apply to any part of a public
- official's official compensation package. [ORS 244.040(2)(a)].

- 19 As the Public Works Director, John Phelan is assigned a County vehicle to use for County
- business and to travel between work and home. County policy prohibits employees from
- using assigned County vehicles for any non-county business. That policy, adopted in
- 22 2002, has not been altered or amended.

- On March 10, 2017, Mr. Phelan used his assigned County vehicle to travel to Salem to
- attend a Commission meeting during which a case in which he was the respondent was
- on the agenda. In so doing, Mr. Phelan used his assigned County vehicle for personal,
- 27 non-county, business, in violation of County policy. Because the County policy was never
- 28 expanded to include personal use of the assigned vehicles, Mr. Phelan's personal use of
- 29 his assigned County vehicle was not authorized by County policy and would not be
- included as part of his official compensation package.

There is a preponderance of evidence to indicate that the primary purpose for Mr. Phelan's travel to Salem was to attend the Commission meeting on March 10th. In his explanation to his superiors at the County, he claims that he attended the Commission meeting in order to defend the County, but the prior matter involved allegations made against Mr. Phelan. In his explanation, Mr. Phelan appears to defend his actions in the prior matter on the basis that because the contract at issue had been vetted by the County counsel, this vetting somehow absolved him personally. As the Commission's case was against Mr. Phelan, the purpose of his appearance was to defend himself, not the County.

The purpose of his visit to Salem was, therefore, personal business.

Available information appears to indicate that Mr. Phelan was fully aware that his use of the County vehicle for this personal business was improper. In his explanation he writes "Knowing full well that this could be challenged," which suggests he was aware that his use of the assigned County vehicle to travel to Salem was unauthorized. He then adds the further justification of his visit to the Gehring farm and his photographing the closed, flooded roads. Information is insufficient to determine whether Mr. Phelan's visit to the Gehring farm was for legitimate County business or was effected solely to cover his unauthorized use of the County vehicle. It is unclear why Mr. Phelan would need to visit the Gehring farm on March 10th to photograph the grader when he and Mr. Heath had already made such a visit and Mr. Heath had sent Mr. Gehring his estimate of a fair market value for the grader. When questioned recently, neither Mr. Gehring nor Mr. Heath could recall anything about Mr. Phelan's March 10th visit to the Gehring farm.

Mr. Phelan's March 10, 2017 reimbursement to the County is further evidence that he was aware his use of the vehicle was for a personal purpose. Had he truly believed that his attendance at the Commission meeting was for a County purpose, there would have been no reason to reimbursement the County for any mileage.

Not only did Mr. Phelan fail to maintain the vehicle use record required by County policy, but his calculation of the mileage and reimbursement rate have no basis in fact. He estimated a distance of only one mile, when his personal use of the vehicle was either 58.8 miles (McMinnville to Salem) or at a minimum 12.4 miles (Gehring farm to Salem).

- 2 Further, the reimbursement rate he used (\$4.00 per mile) appears not to have been based
- on any officially adopted rate. In fact, the County does not actually have a reimbursement
- 4 rate for personal use of assigned vehicles, since such personal use is not authorized.

5

- 6 Finally, in Mr. Phelan's testimony before on the Commission on March 10, 2017, he stated
- 7 that "Since the incidents have been brought before me, I have received ethics training."
- 8 [Commission Meeting Audio Recording, March 10, 2017, Regular Session Part 2, 16:57].
- 9 Mr. Phelan received ethics training before the March 10th Commission meeting, yet he
- still chose to drive the County vehicle to Salem for a personal purpose.

11

- Mr. Phelan's use of his assigned County vehicle for personal business allowed him to
- avoid the financial detriment of having to use his personal vehicle and pay for his own
- 14 gas. This personal benefit would not have otherwise been available to him but for his
- holding his official position and being assigned a County vehicle. There appears to be a
- preponderance of evidence to indicate that John Phelan violated ORS 244.040(1).

- 18 **RECOMMENDATIONS**: The Oregon Government Ethics Commission should make a
- preliminary finding that John Phelan committed one violation of ORS 244.040(1). [Motion
- 20 10].

My reason for attending this hearing on March 10<sup>th</sup> was to testify as to the second charge that there was wrong doing in Safe Conduct award of Yamhill County drug testing agreement (contract). As you know the County Counsel and the union attorney vetted the agreement and approved the agreement. I wanted the Ethics Board with my testimony (which you can get a transcript) to know that the vetting had been done and that Yamhill County and Safe Conduct had not done any improprieties in issuing this contract and I as Public Works Director was to "sign off" on all accounts payable issued to the Public Works department. Russ Heath (Fleet Manager) and I had meet with Mr. Gehring two weeks before and were not able to agree on the value and the process of obtaining the piece of equipment. From that meeting I went to Wheatland Ferry and I'm also attaching a photo taking there of the road being closed time stamped March 10<sup>th</sup>at 11:39. From there I went to Grand Island because of road closer and attaching photo time and date stamped March 10<sup>th</sup> at 11:53. From there I went to Mallard lane and again photo date and time March 10<sup>th</sup> 12:14.
