I am writing to explain the late filing for the Quarter 1 Lobbyist report, accruing a \$70 late filing penalty. The reporting requirements are important to ensure transparency and accountability in lobbying and Oregon Student Voice regrets the delayed submission. We also ask for your consideration of the circumstances that necessitated this and request a one-time waiver of the fees/penalties.

Oregon Student Voice's Chief Operating Officer (COO) who registered the organization recently transitioned out of the organization for a move out of state in February 2019. Oregon Student Voice has a fiscal agent that completes the lobbying reporting on behalf of Oregon Student Voice. Until we began to receive the notices from the Ethics Commission through our fiscal agent, we did not realize that Oregon Student Voice was separately registered and needed to file another report, since our fiscal agent was doing the reporting. 
