



I am writing on behalf of my husband, John Loshbaugh, regarding the Commission's letter dated Sept 9, 2019. John was on the Harrisburg City Council from 2014 or 2015 until 2018. During 2017 myself and his doctor noted a decline in his memory and cognitive abilities.

By May 2018 I had begun checking his email for items that might need attention because he rarely read them. I located the emails about the required SEI reports and found out that he had difficulty in 2017 accessing the records on-line until the City recorder was able to help him gain access. I am not sure he was aware of the fine levied in 2017.

I assisted him with the 2018 report, albeit late. He had difficulty navigating the system and I offered to help by reading the questions and typing his answers then submitting the report. I told him there were fines due and he said he would take care of them. Later in 2018 he resigned his position on Harrisburg City council.

As your records indicate he did not pay the fines. I don't think it was an intentional slight but that he did not remember to mail a check. I am sending this via email for expediency and will mail a check for the penalty imposed due to late filing under separate cover.

- 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against John Lindsey.
- JURISDICTION: At all material times, John Lindsey was a Linn County Commissioner. John Lindsey was a public official subject to the jurisdiction of the Commission pursuant to ORS Chapter 244.

### STIPULATED FACTS:

- A. On June 5, 2017, Commissioner Lindsey sent an email to the County's Planning and Building Director from his County email account, recounting his concerns after visiting a property in his neighborhood the prior day. The email requested that the Director open a complaint file on the property for staff to investigate, because he believed an illegal marijuana operation was on the property.
- B. On June 27, 2017, Commissioner Lindsey sent two emails to the County's Planning and Building Director regarding water laws and zoning ordinances he believed were being violated relevant to the greenhouse on the same neighborhood property.

- C. ORS 244.120 requires public officials to disclose conflicts of interest prior to taking official action, which could or would result in financial impact to the public official, a relative of the public official or a business with which the public official or a relative is associated.
- D. John Lindsey did not disclose a conflict of interest prior to taking the actions described in paragraphs A and B above.
- E. ORS 244.350 authorizes the Commission to assess civil penalties of up to \$10,000 as a result of these violations.
- F. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 244.120(2).

#### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

A. On 1/25/19, the Commission acted to find violation, bring the investigative phase to a close and move to a negotiated settlement or a contested case hearing. The 1/25/19 action was a preliminary finding of violations of Oregon Government Ethics law, as a prelude to a stipulated settlement or a contested case hearing, and not a final conclusion regarding a violation of Oregon Government Ethics law by John Lindsey.

- B. John Lindsey will pay a civil penalty in the amount of \$50 and receive a letter of education, as authorized by ORS 244.350, in order to settle and compromise this matter.

- PURPOSE: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) in the above referenced case against S. Bruce Conner.
- JURISDICTION: At all material times, S. Bruce Conner was contracted with the Port of Astoria (Port) to serve as its Cruise Industry Marketing Director. In this position, Mr. Conner acted as the Port's agent, as defined in OAR 199-005-0035(7), and was a public official subject to the jurisdiction of the Commission pursuant to ORS Chapter 244.

#### 3. FACTS AS ALLEGED:

- A. In addition to serving as the Port's Cruise Industry Marketing Director, S. Bruce Conner owns and operates Sundial Shore Excursions (Sundial), a company that provides shore excursions and tours for cruise passengers in Astoria. Sundial is a business with which Mr. Conner is associated, as defined in ORS 244.020(2) and ORS 244.020(3).
- B. ORS 244.040(1) prohibits a public official from using or attempting to use the official's position or office to obtain a financial benefit for the public official or a business with which the public official is associated, if the financial benefit would not otherwise be available but for the public official's holding the official position.

- C. ORS 244.040(4) prohibits a public official from attempting to further or furthering the personal gain of the public official through the use of confidential information gained in the course of or by reason of holding the position as a public official.
- D. A conflict of interest means any action, decision, or recommendation by a person acting in their capacity as a public official, the effect of which would or could be to the private financial benefit or detriment of the person or of a business with which the person is associated. [ORS 244.020(1) and ORS 244.020(13)].
- E. ORS 244.120(1) requires that when met with an actual or potential conflict of interest, a public official such as S. Bruce Conner must "notify in writing the person who appointed the public official to office of the nature of the conflict, and request that the appointing authority dispose of the matter giving rise to the conflict."
- F. In May 2016, S. Bruce Conner provided the Port's website administrator with descriptions of Sundial's shore excursions to be posted on the Port's website. Mr. Conner's action had the effect of providing a financial benefit to Sundial. S. Bruce Conner would not have been able to take this action but for his position with the Port.
- G. When S. Bruce Conner provided Sundial's information to be posted on the Port's website, he had a conflict of interest because his action had the effect of providing a financial benefit to Sundial. S. Bruce Conner did not make a written disclosure of his conflict of interest to his appointing authority.
- H. The actions described in paragraph 3(F) constitute a distinct violation of ORS 244.040(1).

- I. The actions described in paragraph 3(G) constitute a distinct violation of ORS 244.120(1).
  - J. In April 2017, S. Bruce Conner used his position at the Port to send e-mails to at least two cruise line shore excursion representatives seeking to gain their support for a Port policy that had the effect of prohibiting other tour operators from directly competing with Sundial.
  - K. In taking this action, S. Bruce Conner used confidential information about the Port's discussion with another tour operator, information that he gained by reason of holding his position as a public official.
  - L. When he took the action described in paragraph 3(J), S. Bruce Conner had a conflict of interest because his action had the effect of providing a financial benefit to Sundial. S. Bruce Conner did not make a written disclosure of his conflict of interest to his appointing authority.
  - M. The actions described in paragraph 3(J) constitute a violation of ORS 244.040(1).
  - N. The actions described in paragraph 3(K) constitute a violation of ORS 244.040(4).
  - O. The actions described in paragraph 3(L) constitute a violation of ORS 244.120(1).
  - P. In September 2018, S. Bruce Conner used his position with the Port to send e-mails to at least two cruise line shore excursion representatives seeking support for the Port policy that had the effect of financially benefitting his company6 by limiting competition. S. Bruce Conner also directed Port staff to send similar e-mails to multiple cruise lines.

- Q. When he took the action described in paragraph 3(P), S. Bruce Conner had a conflict of interest because his action had the effect of providing a financial benefit to Sundial. S. Bruce Conner did not make a written disclosure of it to his appointing authority.
- R. The actions described in paragraph 3(P) constitute a violation of ORS 244.040(1).
- S. The actions described in paragraph 3(Q) constitute a violation of ORS 244.120(1).
- T. ORS 244.350 authorizes the Commission to assess civil penalties of \$5,000.00 per violation or up to \$35,000.00 as a result of the seven violations set forth in paragraphs 3(H), 3(I), 3(M), 3(N), 3(O), 3(R), and 3(S).
- U. ORS 244.360 authorizes the Commission to order S. Bruce Conner to pay a monetary forfeiture equal to twice the amount of financial gain S. Bruce Conner realized as a result of these violations.

V. The Commission contends that results of the investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find three violations of ORS 244.040(1), one violation of ORS 244.040(4), and three violations of ORS 244.120(1).

#### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

A. On August 23, 2019, the Commission acted to find violations, bring the investigative phase to a close, and move to a negotiated settlement or a contested case hearing. The August 23, 2019 action was a preliminary finding of violations of Oregon Government Ethics law, as a prelude to a stipulated settlement or a contested case hearing, and not a final conclusion regarding violations of Oregon Government Ethics law by S. Bruce Conner.

- B. S. Bruce Conner will pay a civil penalty, as authorized by ORS 244.350, in the amount of \$3,500.00 in order to settle and compromise these matters.
- C. By entering into this Stipulated Final Order, S. Bruce Conner will not pay a forfeiture, as authorized by ORS 244.360.
- D. The Commission releases, settles and compromises any and all claims, which have been or could be asserted against S. Bruce Conner within the scope of the above-referenced proceedings.
- E. S. Bruce Conner will initiate no claims, litigation or other action against the Commission as a result of these proceedings.

- D. The Commission contends that the actions described in paragraph (B) above constituted a violation of ORS 192.660(6).
- E. ORS 244.360 authorizes the Commission to assess civil penalties of up to \$1,000 as a result of any violation of ORS 192.660.
- F. The Commission contends that the results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find a violation of ORS 192.660(6).
- G. Ms. Laoisa disagrees with the above conclusions and contends that the results of the investigation, if submitted through exhibits and testimony in a hearing would not establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 192.660(6). In order to conclude this matter, however, Ms. Laoisa agrees to the terms and conditions in this stipulated final order.

### 4. TERMS OF SETTLEMENT:

The parties agree as follows:

A. On 5/31/19, the Commission considered information in the preliminary review phase and acted to find cause to initiate an investigation of these matters. Sarah Laoisa has indicated she wishes to conclude this matter by agreeing to the terms and conditions in this order without completing the investigative phase.

- B. Sarah Laoisa will receive a letter of education in lieu of a civil penalty as authorized by ORS 244.350 in order to settle and compromise this matter.
- C. The Commission releases, settles and compromises any and all claims, which have been or could be asserted against Sarah Laoisa within the scope of the above-referenced proceedings.
- D. Sarah Laoisa will initiate no claims, litigation or other action against the Commission as a result of these proceedings.

Each of the parties further acknowledges that each has had the opportunity to seek the advice of counsel in comparing and reviewing this agreement.

By signing this agreement, Sarah Laoisa agrees to waive her right to a contested case hearing as provided in ORS Chapter 183 and ORS 244.370. This order shall be the final order and all information in the Commission files on this matter shall become part of the record.

By signing this agreement, Sarah Laoisa agrees to waive her right to obtain judicial review of this order as provided in ORS 183.482.

- 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Lori Cheek.
- 2. <u>JURISDICTION</u>: At all material times, Lori Cheek was a member of the Board of Directors for the Harney County School District #3 (Burns School District). As the governing body of a public body, the members of the Board of Directors are subject to the executive session provisions of Oregon Public Meetings law as set forth in ORS 192.660 and ORS 192.685.

#### 3. STIPULATED FACTS:

- A. Members of the Burns School District Board of Directors held an executive session on each of the following dates: 11/13/18, 11/20/18, and 1/16/19. At each of these executive sessions, a statutory authorization cited was ORS 192.660(2)(b) to discipline, dismiss, or hear complaints about an officer, employee, or agent. Information indicates that during each of these executive sessions, a complaint against the Superintendent was a topic of discussion.
- B. Lori Cheek participated in the executive session held by the Burns School District Board of Directors on 11/20/18, during which the Directors made a decision to use District funds to pay a specific law firm to conduct an

investigation into a complaint received against the District Superintendent. The costs for this investigation were estimated to be \$1,000 for three hours of work.

- C. Lori Cheek participated in the executive session held by the Burns School District Board of Directors on 1/16/19, during which the Directors made a decision to accept the recommendation in the investigation report produced by the law firm.
- D. ORS 192.660(6) prohibits a governing body from making a final decision in executive session.
- E. The Commission contends that the actions described in paragraph (B) and(C) above constitute two violations of ORS 192.660(6).
- F. ORS 244.360 authorizes the Commission to assess civil penalties of up to \$1,000 as a result of any violation of ORS 192.660.
- G. The Commission contends that the results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find a violation of ORS 192.660(6).
- H. Lori Cheek disagrees with the above conclusions and contends that the results of the investigation, if submitted through exhibits and testimony in a hearing would not establish a preponderance of evidence in support of a post-hearing order to find violations of ORS 192.660(6). In order to conclude this matter, however, Lori Cheek agrees to the terms and conditions in this stipulated final order.

### 4. TERMS OF SETTLEMENT:

- A. On 5/31/19, the Commission considered information in the preliminary review phase and acted to find cause to initiate an investigation of these matters. - 1. <u>PURPOSE</u>: The purpose of this stipulated final order is to settle any and all claims, allegations and charges by the Oregon Government Ethics Commission (Commission) against Michael McKoen.
- 2. <u>JURISDICTION</u>: At all material times, Michael McKoen was a member of the Board of Directors (Board) for the Basin Ambulance Service District (District). As the governing body of a public body, the members of the Board are subject to the executive session provisions of Oregon Public Meetings law as set forth in ORS 192.660 and ORS 192.685.

### 3. STIPULATED FACTS:

- A. Michael McKoen participated in an executive session held by the Board on April 18, 2019. When the Board convened this executive session, the presiding officer of the Board did not identify the specific statutory authorization for holding the executive session.
- B. ORS 192.660(1) provides that a governing body of a public body may hold an executive session "after the presiding officer has identified the authorization under ORS 192.610 to 192.690 for holding the executive session."

- C. By participating in an executive session for which the presiding officer failed to identify the statutory authorization, Michael McKoen violated ORS 192.660(1).
- D. In the executive session, the Board discussed complaints against and considered dismissal of three District volunteers.
- E. ORS 192.660(2)(b) provides that a governing body may go into executive session to "consider the dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent who does not request an open hearing." The statutory prerequisite is that the governing body must provide the affected persons with sufficient notice of the executive session and an opportunity to request an open hearing.
- F. The Board had not satisfied the statutory prerequisites before it discussed the complaints against and dismissal of the three volunteers in the executive session on April 18, 2019.
- G. By participating in an executive session when the Board discussed the three volunteers without having satisfied the statutory prerequisites, Michael McKoen violated ORS 192.660(2).
- H. The actions set forth in paragraphs 3(C) and 3(G) constitute two distinct violations of ORS 192.660.
- ORS 244.350(2)(a) authorizes the Commission to assess civil penalties of up to \$1,000 for each violation of ORS 192.660.
- J. The results of the Commission investigation, if submitted through exhibits and testimony at a contested case hearing, would establish a preponderance of evidence in support of a post-hearing order to find two violations of ORS 192,660.
