SUMMARY

Digest: The Act keeps certain provider taxes in place. (Flesch Readability Score: 71.8).

Extends to 20__ the assessments on earnings from health plan premiums and payments by the Oregon Health Authority to managed care organizations.

Extends to 20__ the assessment on hospitals.

A BILL FOR AN ACT

Relating to funding to improve access to health care; creating new provisions; amending ORS 414.871 and 414.884 and sections 12, 13 and 14, chapter 736, Oregon Laws 2003, and sections 4 and 8, chapter 538, Oregon Laws 2017.

Be It Enacted by the People of the State of Oregon:

EXTENSION OF HEALTH INSURANCE PREMIUM AND MANAGED CARE ASSESSMENTS

SECTION 1. Section 4, chapter 538, Oregon Laws 2017, as amended by section 5, chapter 2, Oregon Laws 2019, is amended to read:

Sec. 4. Section 3, chapter 538, Oregon Laws 2017, applies to premium equivalents received by the Public Employees' Benefit Board, or a third party administrator that contracts with the board to administer a self-insured health benefit plan, during the period from January 1, [2020] **2027**, through December 31, [2026] **20__**.

13 414.871. ORS 414.853 to 414.869 and 414.900 apply to net revenues earned
14 by hospitals during a period beginning July 1, [2019] **2025**, and ending the
15 earlier of September 30, [2025] **20__**, or the date on which the assessment no
16 longer qualifies for federal financial participation under Title XIX or XXI
17 of the Social Security Act.
