

Mercer Caveats State of Oregon

This report includes CY25 CCO capitation rates. The purpose of this report is to facilitate discussion with the Oregon Health Authority (OHA) and Coordinated Care Organizations (CCOs) regarding CY25 rate development assumptions and results.
