On May 22nd at 7:30AM, at Santiam Hospital, an in-person announcement was made to our Medical Staff and Leadership, and almost all came in attendance. Next came the virtual All Staff Forum. Over 250 staff members were logged in, listening closely. We followed up quickly with an all-staff email announcement of the affiliation

pursuit, staff FAQs, a link to a staff survey, as well as our press release; this information was also posted on our internal website, The Pulse.

Maggie Hudson, President & CEO spent the remainder of the morning of May 22nd calling our key partners, including Salem Health, St. Charles, Marion County Commissioners, Foundation Board members and large donors.

A press release was submitted to media and subsequently, an email announcement with press release was issued to the Auxiliary, Chaplains, IHO partners, local government representatives and other key stakeholders.

Posts were issued on all of our social media platforms and a banner on our website directed visitors to a landing page shared with Samaritan. The page features the press release as well as public FAQs that will be periodically updated.

Follow up meetings were held with every hospital department and clinic between May 22nd and June 11th.

Townhalls with the communities we serve were held on June 18th, 26th and 27th.

Monthly updates continue to be communicated to Department Directors, All Staff and Medical Staff.

Samaritan's Response:

There is no written feedback that was obtained from communications with key stakeholders. Verbal feedback has been overwhelmingly positive. Samaritan stakeholders are excited to grow our market share and welcome another hospital and clinics into our system.

A recurring question is if we are purchasing Santiam and, given our current financial challenges, if now is the best time for such a purchase. We have corrected the misassumption that this is a purchase by Samaritan of Santiam and reaffirmed that this is an affiliation of two great organizations which is key to Samaritan's growth strategy and Santiam's stability.

While it will take years to fully integrate, we believe this affiliation will help both organizations achieve our missions and become more financially stable to face the challenges of health care delivery into the future.

Corvallis, Ore., May 22, 2024 – Samaritan Health Services and Santiam Hospital & Clinics announced today their plan to pursue formal affiliation. The organizations have signed a nonbinding letter of intent (LOI) to allow the parties to further evaluate the affiliation with the anticipated outcome of Santiam Hospital & Clinics becoming part of Samaritan Health Services.

"We are excited about working more closely with the team at Santiam Hospital & Clinics as we move into this next phase of our collaboration," said Doug Boysen, president and chief executive officer of Samaritan Health Services. "Throughout our discussions, it has been clear that the alignment of our organizations — our missions, values and culture —positions us well to strengthen services across the region for those in our communities."

"We are focused on serving our respective communities and learning from each other. Our shared strengths position us well for continued vitality so we both remain long-lasting institutions," said Maggie Hudson, president and chief executive officer of Santiam Hospital & Clinics. "Looking toward this process, I'm driven by the relationships we are forging between our organizations, leaders and clinicians in order to better serve our communities."

As nonprofit, community-based health systems with similar missions, visions, values and cultures, both organizations share a commitment to keeping services local. Joining together through affiliation would strengthen both organizations through increased access to services, improving health equity and enhancing services provided to communities throughout the mid-Willamette Valley and central Oregon coast regions.

"The health care industry is evolving, and we believe that this affiliation will ensure that Samaritan Health Services and Santiam Hospital & Clinics both remain sustainable, strong institutions, providing access to quality health care," said Boysen.

The organizations are committed to maintaining local governance and leadership and retaining existing staff and clinicians.

Frequently Asked Questions

What Does This Letter of Intent (LOI) Mean?

The nonbinding letter of intent signed by Samaritan Health Services and Santiam Hospital & Clinics leadership means that we are both interested in working toward Santiam Hospital & Clinics joining Samaritan Health Services. Because the agreement is nonbinding, either organization can decide to stop participating in the process.

What Is the Anticipated Outcome of the LOI?

The outcome of the LOI is two-fold: first to begin this phase of due diligence and second to determine if we want to move forward with a formal affiliation in the future. If that is decided, both organizations will jointly submit a formal request for affiliation to the state.

Will the Oregon Health Authority Review This Request?

If, as we navigate through all stages of the affiliation process, both Samaritan and Santiam ultimately decide to pursue a formal integration, a definitive agreement would be signed, and we will request review from OHA's Health Care Market Oversight program.

What Is the Timeline for This Affiliation Process?

Complete affiliation could take up to a year or more.

How Did These Two Organizations Decide to Move in This Direction?

With thorough research into health care organizations, leadership identified that both organizations are well matched in their health care services, vision, mission, and cultural alignment.

Who Made the Decision to Pursue Affiliation?

The decision to explore potential affiliation was made jointly by both system's executive leadership and boards of directors. Both boards supported this next step in the process unanimously.

What Does This Mean for Employees at Santiam Hospital & Clinics & Samaritan Health Services?

In the near term, some employees may be asked to contribute data to help support next steps. The organizations are committed to maintaining local governance and leadership and retaining existing staff and clinicians. In terms of clinical service, this process will not impact how either organization serves the community or provides patient care.

How Will This Impact the Care That Patients Receive at Each System?

In the near term, there should be no change to patient care as a result of this portion of the process. Both of our missions center on providing care for our communities, and that remains our priority.

How Will This Impact the Service That Members Receive at Samaritan Health Plans?

There should be no change to the service members of Samaritan Health Plans receive as a result of this affiliation process.

How Will This Impact the Donors & Supporters?

Our alignment extends to local philanthropy as well as clinical care. Donors can support local services through the Santiam Hospital & Clinics Foundation or any of the five Samaritan hospital foundations.

How Can Community Members Formally Share Their Thoughts About the Affiliation?

The OHA review process includes a period of public comment which would allow members of the community to share their thoughts.

How Will Employees & Community Members Learn More About the Process?

Executive leadership at both Samaritan Health Services and Santiam Hospital & Clinics are committed to providing updated information as it becomes available throughout this process. These updates may look like emails, meetings and employee forums for internal audiences or public announcements, community town halls and additions to the FAQ for the community.

Will United Healthcare or Kaiser insurance be accepted once Santiam Hospital & Clinics becomes part of the Samaritan Health Services?

As we are at the beginning of this affiliation process, there are more questions than answers at present. We are committed to transparent communication throughout and will provide ongoing information as it becomes available.

Will Santiam clinics also become part of the Samaritan Health Services System? Will all the Santiam Hospital Medical Clinics stay open?

Yes, Santiam Medical Clinics will remain open to serve patients and would ultimately join Samaritan Medical Group.

How will Samaritan Health Services and Santiam Hospital & Clinics benefit from this affiliation?

This potential affiliation positions Samaritan Health Services and Santiam Hospital & Clinics to strengthen services across the region for those in their communities. Bringing together expertise from both systems will enhance the respective operations and services of both.

Q: Why is Santiam Hospital & Clinics considering an affiliation with another Health System?

A: As we know, the healthcare environment is continuously changing; as a result, partnerships have become more important than ever. Partnerships and collaboration are the models of providing exceptional healthcare now and into the future. A symbiotic partnership will allow us to maintain our services and continue to pivot and grow to meet our community's needs.

Q: Who made the decision for Santiam Hospital & Clinics to potentially transition from an independent hospital and clinics not-for-profit to a larger non-profit system?

A: Santiam Hospital & Clinics decision to explore potential affiliation with Samaritan Health Services was a unanimous decision by Santiam Hospital & Clinics Board of Directors, CEO and President, and Executive Leadership. Administration and Departments - Santiam Hospital

Q: Why Samaritan Health Services?

A: After thorough research into healthcare organizations, we have agreed that Samaritan Health Services is the most aligned health care system with Santiam Hospital & Clinics in the services offered, mission, vision, culture, and community alignment. Local governance and the commitment to enhancing services is a key strength of the Samaritan system.

Q: What will Santiam Hospital & Clinics be called?

A: As we are at the beginning of this affiliation process, there are more questions than answers at present. We are committed to transparent communication throughout and will provide ongoing information as it becomes available.

Q: Will Santiam Hospital & Clinics retain its not-for-profit status?

A: Yes, Samaritan Health Services is also a non-profit. This transaction is called a "Member Substitution." In effect, it is a like-for-like health system.

Q: What is a Letter of Intent (LOI?)

A: The non-binding LOI signed by Samaritan Health Services and Santiam Hospital & Clinics leadership demonstrates both systems are interested in exploring the possibility of Santiam Hospital & Clinics joining Samaritan Health Services. Santiam Hospital & Clinics and Samaritan Health Services are committed to competitive wages and benefits. We will have transparent communication throughout and will provide ongoing information as it becomes available.

Q: Is my job secure?

A: Santiam Hospital & Clinics and Samaritan Health Services are committed to retaining clinicians and staff.

A: Our initial analysis indicates that benefits and compensation may be enhanced by joining Samaritan Health Services. Santiam Hospital & Clinics and Samaritan Health Services are committed to competitive wages and benefits. We will have transparent communication throughout and will provide ongoing information as it becomes available.

Q: Will Santiam Hospital & Clinics employees continue to have a twenty percent discount from hospital and clinic bills if Santiam chooses to affiliate with Samaritan Health Services?

A: This is a question that we hope to have an answer to within the coming months as we know that employees value this added benefit. We do know that Samaritan Health Services is self-insured, and we will remain as a preferred network just as we are right now. We are committed to transparent communication throughout and will provide ongoing information as it becomes available.

Q: Will Santiam Hospital & Clinics employees continue to be able to use the on-site pharmacy with its continued benefits of lower cost prescriptions if Santiam chooses to affiliate with Samaritan Health Services?

A: Yes, our pharmacy on-site will continue to be accessible for employees and their families, we will continue to provide transparent communication throughout and will provide updated information as it becomes available.

Q: Is there a program of Samaritan Health Services for incentivizing health, wellness, and volunteerism that Santiam will adopt if they choose to affiliate?

A: Samaritan Health Services has a program called Healthy Habit Incentives via their health plan. Regarding volunteering, it is rewarded via recognition and the good being done in their communities, there is not a specific incentive program to volunteer, it is an expectation ingrained in their culture much like Santiam transitioned to this last year.

Q: Will Santiam Hospital & Clinics and Samaritan Health Services Leadership be hosting a joint staff forum?

A: Yes, Samaritan Health Services Leadership is looking forward to hearing more from Santiam Hospital & Clinics employees. Stay tuned for an invite.

Q: Will Santiam Hospital & Clinics adopt the pay schedule of Samaritan Health Services, and will seniority be transferred?

A: As we go through the integration process, we will learn more about how longevity and pay schedules will transition over, we are committed to transparent communication and will update when more information becomes available.

Q: Will Santiam Hospital & Clinics current health insurance, Consociates change to Samaritan's Health Insurance Plan?

A: Yes, Santiam Hospital & Clinics will no longer have Consociates if we become part of Samaritan Health Services. We would have Samaritan's Health Insurance Plan.

Q: When will staff of Santiam Hospital & Clinics be trained on the Samaritan Epic?

A: This process will take a year if we choose to affiliate. We are aiming to transition to Samaritan Epic in April 2025.

Q: Most importantly, will the Foundation's Dodgeball Tournament still be held?

A: Definitively, yes!

Q. Will Samaritan Health Services support and maintain employing Licensed Nurse Practitioners (LPNs) at Santiam Hospital & Clinics?

A. Samaritan Health Services supports and employes LPNs throughout the hospital systems and is committed to retaining Santiam Hospital & Clinics LPNs.

Q. Does Samaritan Health Services have Community Health Workers as part of their model of care addressing social determinants of health?





Regarding: Verbal Feedback received on Santiam Hospital & Clinics pursuit to Affiliation with Samaritan Health Services

Overall, the pulse in the community is supportive of the pursuit to affiliation. Community members have been able to email Santiam at forwardtogether@santiamhospital.org or attend Community Town Halls. In addition, Santiam has a strong community presence through our Integrated Health and Outreach program and staff have been available at chamber meetings, service integration meetings, and outreach events. The feedback is generally supportive of the hospital, and they have appreciated the avenues to communicate with Santiam on the affiliation pursuit. There is excitement around the possibility of expanded services this will bring to our Santiam Region, at the same time there are questions we have been able to listen to and respond to.

Questions have ranged from "Will the hospital name remain Santiam" to will wait times to see a provider be longer after the affiliation" to "Can I see my Dr. I have now or will that be changing?" Stakeholders in Turner, OR had concerns that affiliations can be a disruption and how will that affect the longer-term goal of establishing a clinic in Turner. Community members had questions around Santiam retaining local governance and there is a genuine relief/enthusiasm when community members hear that Santiam will retain their local governance board. Donors in the community who give to our Santiam Hospital & Clinics Foundation were wondering if the donations raised in the canyon would remain in the canyon. They were relieved to hear that the Foundation will remain in place with donations staying in the communities of Santiam. Additionally, patients are interested if Santiam will be part of Samaritan EMR and will the staff they have gotten to know over time be retained throughout the affiliation process.

The trending topic by many community members at outreach events and phone calls is around UnitedHealthcare and Kaiser Insurance. It is known that Samaritan Health Services does not currently have a contract with UnitedHealthcare or Kaiser Insurance and this worries Santiam's patients specifically the aging adult population. Santiam Hospital & Clinics has been consistent with messaging the following: "Throughout the affiliation process, there will be no changes to the health plans that contract with Santiam Hospital & Clinics as a result of affiliation. After integration is complete and the two organizations merge – anticipated for spring 2025 – existing contracts will be evaluated. There will be no contract terminations due to affiliation in 2025. Any contract changes that may occur for 2026 would be communicated in advance of the open enrollment period.

Santiam's email forwardtogether@santiamhospital.org, public FAQs will remain available to the public at <u>Forward Together - Samaritan Health Services</u>. As Santiam receives questions we will continue to listen and respond.



How long have the hospital and Samaritan been talking about the idea and what led to the discussions beginning?

Santiam Hospital & Clinics Leadership have been in discussions with Samaritan Health Services for some time. We have always had a good relationship with Samaritan Health Services and align well with each other.

What are the potential benefits of a formal affiliation for Santiam Hospital's patients and the community it currently serves?

"This potential affiliation is a strategic shift to secure a better future for the patients served by Santiam Hospital & Clinics. It is our commitment to strengthen this long-lasting health care system to be here to serve the residents of the Santiam Canyon, not just for today or tomorrow, but for decades to come."-Maggie Hudson, CEO and President of Santiam Hospital & Clinics.

Thank you for emailing us your concerns and thank you for trusting your care with Santiam Hospital & Clinics.

We appreciate that you choose Santiam as your choice of hospital.

We had three community town halls, and the local paper attended the town hall discussion in Stayton. United Healthcare and Kaiser insurance was a topic that many community members at the Stayton Town Hall had. Community members wanted to know if Santiam Hospital & Clinics would continue to take United Healthcare and Kaiser insurance as the other hospitals/clinics within Samaritan Health Services do not at this time. We communicated during the townhall that there would be changes to health plans via December 2025 as a result of the affiliation and that in the meantime we would be evaluating how to proceed and would give ample notification if anything was to change in 2026. Unfortunately, the paper reported it differently but did make an online correction.

Here is the corrected information, " Throughout the affiliation process, there will be no

changes to the health plans that contract with Santiam Hospital & Clinics as a result of affiliation. After integration is complete and the two organizations merge – anticipated for spring 2025 – existing contracts will be evaluated. There will be no contract terminations due to affiliation in 2025. Any contract changes that may occur for 2026 would be communicated in advance of the open enrollment period.

At the time the affiliation becomes finalized is when Santiam and Samaritan will be able to start having discussions to make decisions around UHC.



In the coming weeks, we will be launching the next phase of our integration planning efforts with Santiam Hospital & Clinics. In order to prepare for the potential affiliation early next year, we will be bringing leaders together from both organizations to develop implementation plans. These plans will not be implemented until a definitive agreement is reached, the Oregon Health Authority approves the transaction, and the affiliation is completed, which is targeted for April 2025. You are receiving this communication because you have been identified as a functional area leader, or subject matter expert who will play an essential role in integration planning and implementation.

You will receive more information in upcoming kick-off meetings related to the Integration Governance Structure and how your functional team will fit into that overall structure. I have also attached a list of functional areas grouped by division for your review. At this time, we have established an integration project management team comprised of Samaritan and Santiam leadership, project managers, and members of a third-party advisory firm, PYA, who have experience facilitating hospital integrations. Good morning. I hope you had a nice weekend.

Over the past two weeks I've heard from many of you about our financial situation and cost reduction plans. I can attest to this - many of you are certainly not afraid to speak your minds! Ultimately, I am glad that many of you are engaged, feel ownership in our future and feel comfortable reaching out directly to me. I read all of your emails and learn from them.

One common theme I've heard is whether we are planning to grow, rather than just cut expenses to better our financial position. I have two thoughts on this. We do need to cut expenses because we had a very rapid deterioration of our financial status. Our situation really started to plummet just within the last few months. A growth strategy takes time and we need rapid improvement. Hence, the importance of a quick cost reduction strategy.

That said, I fundamentally agree that we can't continue to cut our way to prosperity. Growth is also necessary for sustainability. With that in mind, we have several growth strategies in the works. In the future we plan to open new primary care clinic locations, expand some specialty service lines, construct more inpatient beds at Good Samaritan Regional Medical Center and, probably our greatest opportunity, is to bring Santiam Hospital into the Samaritan system.

That last growth opportunity relates to the second question I am commonly hearing. The question is should we be buying another hospital right now? I want to emphasize that we are not "buying" Santiam Hospital. They are choosing to join the Samaritan system. While we will take on their debt when they become part of Samaritan, we will also be taking on their assets and revenue. We are going to be making capital improvements at Santiam, but these improvements are consistent with capital contributions that we make at all of our sites. The business arrangement for Santiam Hospital joining Samaritan is absolutely consistent with how the other five existing Samaritan hospitals joined the system.

Speaking of Santiam Hospital, I am happy to say that last Thursday we signed the definitive agreements to consummate the affiliation. This is a huge milestone for this project and is reflective of the great collaboration we are having with that organization. This, however, does not mean that it is a done deal. We must still obtain approval from the state of Oregon and we have other integration work before we can close the transaction. As of right now, we are scheduled for them to officially join Samaritan on June 1, 2025.

As I said above, Santiam Hospital will further our growth strategy because it will allow us to serve 40,000 new people. It will also turn our five hospital system into a six hospital system with more assets and economies of scale. Most importantly, though, it will allow Santiam Hospital to continue to sustainably provide healthcare services to their communities.

Subject: Integration Planning Update

Hello all,

As you read in Doug's Monday Morning Virtual Huddle, last week's signing of the definitive agreement marked an exciting milestone in our integration efforts with Santiam Hospital & Clinics. As we continue to advance our planning efforts, I wanted to share the updated target timeline and details on our planning efforts.

We anticipate fully integrating our two systems will take us more than a year. Because of the complexity involved in combining our organizations, all affiliation efforts will be planned and orchestrated at the system level. At present, individual departments or leaders should not independently engage their counterparts at Santiam.

The system plan calls for staggering the integration of our operations and core IT systems to provide Santiam and Samaritan teams with the time needed for planning and execution. The timeline below outlines integration priorities for the first ~60 days. Please note the *dates below are tentative* as they are dependent on receiving approval from the Oregon Hospital Authority (OHA).

- June 1, 2025, Target Transaction Close Date
 - Santiam Hospital & Clinics becomes Samaritan Santiam Hospital
 - Santiam employees become Samaritan employees
 - Santiam clinicians become part of Samaritan Medical Group
- August 1, 2025, Target Epic & Associated Systems Go-Live
 - Santiam conversion onto SHS Epic Instance
 - Peoplesoft for Accounting, Finance, and Supply Chain
 - Credentialing, Licensing, Payor Contracting, Billing & Coding

The items listed above represent only a fraction of the integration activities. Timelines still need to be determined for many items, including hospital accreditation, additional IT application conversions, optimizing systems based on shared learnings from our planning efforts, growth initiative exploration and planning, and much more.

For the remainder of 2024, our integration planning efforts will largely focus on the following areas:

- Information Services
- Human Resources
- Medical Group
- Supply Chain

In January 2025, we anticipate formally kicking off all integration planning efforts in coordination with PYA, a healthcare integration consultant we have engaged to support this work. We will leverage their expertise and tools to assist us throughout this process.

Please be on the lookout for additional updates in the coming months and thank you in advance for your engagement in these planning efforts. We are very excited to be moving forward together, and it will not be possible without your leadership and support.






