Proposed Health Information Technology Oversight Council (HITOC) Membership

HITOC members represent a broad range of organizations and communities that are impacted by Health Information Technology in Oregon, including the Nine Federally Recognized Tribes of Oregon, consumer/patient advocates, healthcare providers, hospitals, health plans, coordinated care organizations (CCOs), oral health providers, behavioral health providers, academic researchers, and community-based organizations. HITOC members and the groups they represent use a wide array of health IT tools and systems, and HITOC strives to represent the diversity of people living in Oregon. Technology vendors are not eligible to serve on HITOC. HITOC's bylaws require 11-15 members.

This slate represents 14 voting members and one ex officio member. One voting seat remains open for a Tribal member. HITOC membership is granted to the individuals that appear below and not to the organizations that employ them.
