Outline for Technical Assistance and Q & A Webinar

The primary goals of the RFI:

- To ensure alignment of future funding opportunities with the outcomes and needs identified in the Behavioral Health Residential+ Facility Study.
- Increase community agency, coordination, and voice throughout the funding process.
- To guide and inform the 2025-2027 biennial budgetary request for resources to expand behavioral health residential treatment capacity (*Please note: this is **not** a solicitation*).

Goals of the Request for Information (RFI)

Behavioral Health Residential+ Facility Study Overview:

OHA retained the Public Consulting Group to conduct the Behavioral Health Residential+ Facility Study to analyze behavioral health bed capacity needs in Oregon.

The Behavioral Health Residential+ Facility Study includes:

- 5-year plan to expand capacity across the state based on identified need.
- Identifies current capacity and unmet need by Trauma System Area for the following facility types: inpatient psychiatric, mental health residential treatment, SUD residential treatment, and withdrawal management.
- Estimated capital construction costs for new facilities.
- Snapshot of overall behavioral health system needs, based on qualitative research and a survey of providers.

Data Collection & Analysis

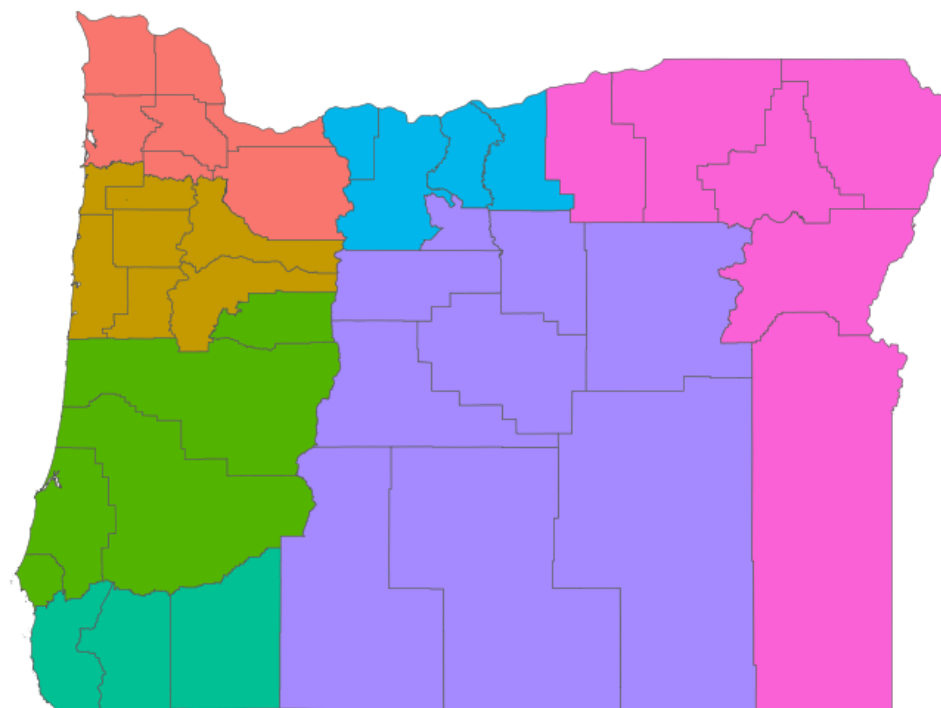
Current Facility Inventory:

- The Behavioral Health Residential+ Facility Study created an inventory of the current facilities in Oregon falling within the project scope and their associated bed capacities.

Mapping of Current Capacity by Trauma System Area:

- After facilities were identified, they were mapped per their respective [Trauma System Area](#). The study then analyzed the number of beds in each trauma area and the number of beds per 100,000 population for each trauma area by facility type.

Community Engagement:

The Behavioral Health Residential+ Facility Study details OHA's community engagement goals and methods. Below are some of the key themes around community engagement:

- Actively involving a diverse range of community members.
- Engaging Oregonians with lived experiences within the behavioral health system to provide feedback which will influence future funding analysis and recommendations.
- Redistribution of power by investing funds back into communities in a way that best meets the needs of their unique population.

Community Engagement (continued):



In addition to the key themes of community engagement noted in the Behavioral Health Residential+ Facility Study, the Governor is also prioritizing collaboration among community organizations within the Trauma System Areas.

Specifically, encouraging a collective approach to increasing needed capacity identified throughout each trauma area.

- Although this does not constitute a solicitation, these responses will be thoroughly analyzed and documented.
- RFI responses will provide valuable data that will inform alignment with [OHA's Strategic Plan](#) and budgetary requests for the next biennium.
- This collaborative effort is an opportunity for your organization to highlight the experience of your community and advocate for the unique needs of the population you serve.
