



## What is Wraparound?

Wraparound offers a team-based planning and problem-solving approach that assists youth/young adults and their families in addressing the challenges and complex needs being experienced.

### Eligibility Criteria:

- 0-21 years of age
- Resides in Jackson or Josephine County
- Experiencing complex needs *and* are involved in two or more child/young adult serving systems \*
- Be approved by a Wraparound Review Committee.

\*Systems include: Behavioral health; IEP or 504 Plan at school; Juvenile Justice; ODHS-Child Welfare; Intellectual/Developmental Disabilities; are homeless or have complex medical conditions.

Wraparound is available to all Medicaid eligible individuals 0-21 years of age who are enrolled in a higher level of care including residential treatment services and/or a program for Commercial Sexually Exploited Children.

For individuals served under Medicaid, a mental health assessment must be obtained within 1 year of the Wraparound referral.

## Where do I start?

## Wraparound

A process that allows for families, community and involved agencies to join together to help youth and young adults achieve success within their home, community, school and/or work settings.

## Wraparound Team & Plan



- Wraparound works to bring together a team that supports the youth/young adult and the family through the challenges they are facing.
- The youth/young adult and their family choose who they want as a part of their team and work with their team to create goals and a team mission.
- The team works to develop a plan that is individualized and supported by the strengths of the youth/young adult and the family.
- Wraparound believes the best outcomes are achieved when youth/young adults and their family work with their team and guide their own meetings. The formula is simple but powerful.



## How Does Wraparound Help?

Upon being approved for Wraparound, you will be introduced to a Wraparound Care Coordinator who will help guide you through the Wraparound process and support you in identifying your strengths, needs and develop your family's goals. You will have access to a Youth Peer and/or Family Peer Partner who aim to support the voice and choice of the youth/young adult and family through a framework of self-advocacy and empowerment. Youth and Family Peer Partners offer the benefits of support through their own lived experience.

## Why Should I Participate?

- You will learn strategies to help you maintain and build success in your home, community school and/or work settings.
- You will gain support in identifying your strengths and finding ways to build on these.
- You will learn and gain confidence in navigating community systems.
- You will receive appropriate services and supports based on your needs.
- Wraparound is a trauma informed, evidence-based practice.
