Good News and Updates!

Raíces de Bienestar (Raíces) will be opening doors to a new space in October! The organization recently held a mobile health event for Latine elders in Washington County in partnership with Centro Cultural. Almost 50 individuals received services on site and nine were enrolled for continued therapy services. Raíces also learned we are a recipient of the PGE Drive Change grant to receive funding for an electric mobile mental health vehicle, projected to be procured in late 2025 or early 2026.

Oregon Advocacy Commissions Office OACO will host focus groups that will discuss health equity recommendations on the following focal areas: Community Justice, Healthcare, and Education will begin in the coming months.

OACO will also be working with commissioners to move the work forward on the health equity recommendations where it aligns with commission priorities.
