# HRSN CCO Variable Admin Fee Schedule

Effective January 1, 2025

CCO admin payments<sup>1</sup> compensate CCOs for administrative tasks that are required of the CCO based on the CCO's contract with the State. These tasks include case management, outreach and engagement, screenings, provider network management, payment and claims processing, member services, and overhead.
