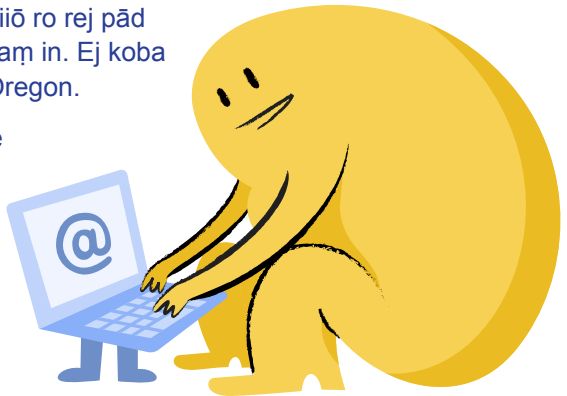
## Bök eddo in kõllā wōnāñ ito-itak ñan appoinment ko, āinwōt:
