



## IMPORTANT NOTICE FROM THE OREGON EDUCATORS BENEFIT BOARD (OEBB) ABOUT YOUR PRESCRIPTION DRUG COVERAGE AND MEDICARE

**Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with OEBB and your options under Medicare's prescription drug coverage.** This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage in your area. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

**There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:**

1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
2. OEBB has determined that the 2023-24 plan year prescription drug coverage offered by Kaiser Permanente Medical Plans 1, 2A, 2B, 3, & Bronze, and Moda Health Medical Plans 1, 2, 3, 4, 5, 6, & 7 on average for all plan participants, are expected to pay out as much as standard Medicare prescription drug coverage pays and **IS** therefore considered **Creditable Coverage**. (Note: The only OEBB plan NOT considered creditable coverage for the 2023-24 plan year is the Moda Health Bronze Plan.) Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.

### When Can You Join A Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15th through December 7<sup>th</sup>. However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

### What Happens To Your Current Coverage If You Decide to Join A Medicare Drug Plan?

If you decide to join a Medicare drug plan, your current OEBB coverage could be affected. If you are a Medicare-eligible **active employee** or a Medicare-eligible dependent of an active employee, you can keep the OEBB coverage even if you elect Part D and your OEBB plan will coordinate with Part D coverage. If you are a Medicare-eligible **early retiree** or a Medicare-eligible dependent of an early retiree, your OEBB medical and pharmacy coverage will terminate on the day before you become Medicare-eligible. If you decide to join a Medicare drug plan and drop your current OEBB early retiree coverage, be aware that you and your dependents will not be able to re-enroll in OEBB early retiree coverage in the future.

### When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with OEBB and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later. If you go 63 continuous days or longer without creditable prescription drug coverage, your monthly premium may go up by at least 1 percent of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19 percent higher than the Medicare base
