OREGON STATE HOSPITAL PATIENT PROPERTY/ITEM ACCESS LIST

CONTRABAND

- Drugs
- Ethanol (drinking alcohol)
- Explosives

- Lighters, matches, incendiary devices or flammable liquids
- Weapons

PROHIBITED ITEMS: NO ACCESS ALLOWED

- Aerosol spray cans or bottles
- Any device with internet capability
- Any item with ethyl, methyl, or isopropyl alcohol as the first or second ingredient
- Aromatherapy products (unless indicated on OT assessment and MD ordered)
- Cameras or recording devices of any kind per OSH Policy and Procedure 7.003, "Photographing or Recording of Patients"
- Cell phone
- Clipboards or rulers with metal parts
- Clothing with chains or spikes, or torn clothing (except factory distressed)
- Computer storage (hard drives, solid state drives or m.2 flash drives)
- Excess Personal Property property which cannot be stored in the designated storage in the patient's room or personal storage space on the unit
- Foil, tin and aluminum (except pre-packaged food wrapping)
- Glass, mirror, or ceramic items
- Gum (unless indicated on OT assessment and MD ordered)
- Hair dye (exceptions include hair dye applied by OSH hairdresser after IDT approval)
- Identification documents, keys, and valuables not stored in accordance with OSH Policy and Procedure 8.037, "Patient Property and Valuables"
- Items related to flammability: Any chargers, electronics cords, power strips, surge protectors, extension cords, plug or outlet adapters not approved or issued by OSH
- Items that are manipulated or altered into something other than original, intended use
- Items with drug, tobacco, alcohol, gang, vulgarity, bigotry, overtly violent or sexually explicit content
- Items intended for the use of escape or elopement
- All Jewelry, with exceptions for the following:
 - Earrings or Piercings that are studs, hoops up to 1inch in diameter (the size of a quarter or smaller), dangles no longer than 1.5 inches
 - Bracelets or Anklets that are easy breakaway, no metal, AND no clasp
 - Watches that are plastic or rubber based, primarily non-metal,
 AND no glass screen (limited to one)
 - Rings that are not significantly raised
- Metal cans, can openers, and French press with glass or metal parts
- Non-OSH issued alarm clock radios or radios
- Non-OSH issued coffee or tea
- Non-OSH issued clothing hangers
- Non-OSH issued pens/pencils/markers (must be "mini" length)
- Non-OSH issued tape
- Pantyhose, knee-high hose, and anything longer than crew sock
- Personal Clothing In Patient Room that exceeds the following -
 - 10 Clothing "Bottoms" (shorts, pants, skirt)
 - 10 Clothing "Tops" (shirts, dresses)
 - 15 Underwear
 - 5 Bras/Undershirts
 - 15 pair of Socks

- 2 Hooded Sweatshirts
- 2 Coats
- 2 Hats
 - Personal Bedding (2 pillows, comforter or blanket, and a sheet set)

PROHIBITED ITEMS: NO ACCESS ALLOWED CONTINUED:

- Plastic bags or plastic wrap
- Prescription or over-the-counter drugs, herbal supplements, or other supplements per OSH Policy and Procedure 6.055, "Medication Management"
- Razor blade
- Safety pins, tacks, paperclips, and metal hair accessories
- SD Cards/micro SD cards/SD card adapters
- Spiral notebooks
- Sports equipment (unless approved by the Program Executive Team)
- Tattooing, piercing or cutting devices
- Toxic glues, paint, alcohol-based products, thinner or solvents
- Wire, cables, cords, or rope longer than 9 inches

TIER 1: CHECKOUT FOR OFF-UNIT USE, SPECIFIED LOCATIONS ONLY

- Cash exceeding \$30 per OSH Policy and Procedure 4.010, "Handling Patient Funds" (OFF GROUNDS)
- Flash Drives (EDUCATION)
- Perfume, cologne, body spray, and scented lotions (OFF GROUNDS)
- Purses or bags with strap(s), and backpacks (OFF GROUNDS, OUTSIDE SECURE PERIMETER, WORK OR SCHOOL)
- Scarves, neckties, suspenders, bandanas, belts, and detachable belt buckles (INTERVIEW OR COURT)
- Work and/or metal-toed boots (GROUNDS MAINTENANCE)

TIER 2: CHECKOUT FOR ON-UNIT USE, SUPERVISED

- OSH Issued electric shavers, trimmers, and hot tools (i.e. curling iron, flat iron, hair dryer)
- Scissors, including safety scissors
- Sewing or craft needles, knitting needles, or crochet hooks
- String, twine, thread, or yarn (no longer than 9 inches)

TIER 3: CHECKOUT FOR ON-UNIT USE, UNSUPERVISED

- Dental floss (no longer than 9 inches), nail clippers, and tweezers
- Discs (ex. CDs, DVDs and games)
- Stringed instruments (must be supervised in patient room)
