- Update on peer groups.
 - Child Welfare Peer Group has met multiple times with good engagement.
 - Coordinator/Lead Peer Group has met multiple times and has a monthly meeting on the calendar. Engagement needs bolstering. Peers identified need for training and resources on drafting prevention recommendations and addressing vicarious trauma.
 - Medical Provider Peer Group met. Determining frequency. Good statewide representation. Medical Examiner so valuable and not always participating. Records can be ordered from State Medical Examiner Office. Peers identified need for onboarding to understand role. Also identified need to have access to records to have a thorough effective review.
 - Jenn Johnson to outreach when school in session to education providers.
- Robust discussion about State Team making efforts to remove barriers to medical providers on county teams having access to records. Support for coordinators in facilitating this is important. Identified tasks: 1. Write guidance for obtaining records. 2. Provide record request information for major hospitals and State Medical Examiner records. 3. Research and provide password protected online record storage to increase comfort in record sharing. 4. Draft letter from State Team explaining the need to share records for review and identifying the related statute 5. Possible training through OCAS for medical providers. Agreement to use time next State Team meeting to move this forward.
- Oregon Department of Education hiring Substance Use Disorder Prevention position.
- Discussion regarding Malheur grant to have a "peer" in the school system who is there specifically for students to connect with if they want to talk with someone about substance use, including parents who use, and he trains on Narcan as well. This is separate from a school counselor. They are tracking data and Cynthia Floyd will share.
- Discussed value in having presentation to team by coordinators to enhance understanding of what goes into preparing for, facilitating, and following up from a county team meeting. This will improve capacity for State Team support of county teams.
- See prevention recommendation spreadsheet for state team response to each county team prevention recommendation.
- Child Welfare submitted a request to get data on how many families are impacted by substance abuse and what substances from the Natural Language research. ODHS is about a year out from having a dashboard, but they will be getting the data in quarterly reports and the data can be sorted by county.
