



3rd Quarter 2023 Report (July 1 – September 30)

Percent change evaluated relative to 3rd Quarter 2022

Summary

- The percentage of prescribers enrolled in the PDMP system has stayed consistent compared to the 3rd quarter of 2022 (*Figure 1* and *Table 1*).
- Total Gateway automated queries decreased (-8.9%) while reports viewed increased (1.9%). Web queries also increased (4.9%) compared to 3rd quarter of 2022 (*Table 3*).
- Overall, the total number of prescriptions for controlled substances have increased (1.6%) compared to the 3rd quarter of 2022. Gabapentin is the most prescribed substance in the system with a slight increase (0.2%) in prescriptions over Q3 2022. Stimulant prescriptions continue to increase with amphetamine prescriptions up 4.2% and methylphenidate prescriptions increasing 13.1% (*Table 5*).



• *Figure 1* shows the percentage of PDMP-enrolled prescribers over time from 2013-2023. Registration has remained high since 2018, especially among top prescribers.

- Controlled substances were prescribed by 19,164 Oregon providers in Q3 of 2023.
- During the 3rd quarter, 81.2% of enrolled prescribers, 94.9% of the top 4,000 prescribers, and 96.1% of the top 2,000 prescribers used the web portal or Gateway integration.
- The total percentage of enrolled prescribers querying was 81.2%. This has remained consistent since the 3rd quarter of last year when 81.3% of users queried.

• Overall, web queries increased over the last year with the largest increase from delegates. Usage from healthcare providers decreased for both web portal and gateway integration, while pharmacy usage increased.

- In general, enrollment has increased among all except ND disciplines. The greatest increases were in MD/PA/DO (10.4%) and Delegate (12.7%) disciplines over Q3 2022.
- The MD/PA/DO discipline decreased both web portal and integrated usage. Delegates increased usage of the web portal 10.9% over Q3 2022.

- Overall, the number of prescriptions increased 1.6% relative to the 3rd quarter of 2022.
- Gabapentin is the top prescribed drug in the PDMP (14.2% of all prescriptions) with a 0.2% increase in prescribing relative to Q3 2022. The addition of gabapentin as a PDMP-covered substance was effective as of January 1st, 2020.
- Prescriptions for the stimulants amphetamine and methylphenidate increased by 4.2% and 13.1% relative to the same quarter last year.

Note: Naloxone prescriptions are no longer collected by the PDMP as of September 2023.
