Vaccine Finance update by Kelly: A 26-member multidisciplinary steering
committee has been formed to represent various sectors across healthcare. Team
will meet twice a month June through September. Team has established a charter,
group agreements and selected a chair, Dr.Bob Dannenhoffer from Douglas
county health network. Committee has brainstormed and sorted potential
recommendations. July 8th is the next meeting, if anybody is interested in listening

- Bridge Program Update by Nora: The Bridge Access Program (BAP) will provide free COVID-19 vaccines to adults who are uninsured until the program ends in August 2024. The 2023-2024 COVID-19 vaccine procured through the BAP will no longer be recommended once a new vaccine formulation is recommended. BAP vaccines will not be provided for the 2024-25 season. Until the new vaccine formulation is available, providers can continue to request and use BAP vaccines. The public can find a BAP vaccine provider at vaccines.gov.

- RSV Vaccine Update Jill shared an announcement from OIP's listserv last week about RSV vaccine for billable patients. Providers enrolled in the Vaccine Access Program (VAP) can now order adult RSV vaccines, Abrysvo and Arexvy for billable patients who are 60 and older. Orders can be made in ALERT. Last week, the ACIP further refined their RSV vaccine for older adults recommendation. One dose of RSV vaccine is routinely recommended for people 75 and older and for people 60 through 74 years old with chronic health conditions. Adults 60 and older who have previously received an RSV dose do not need to receive another dose this year. And just FYI that a third RSV vaccine for adults has been approved by the FDA and is included in the ACIP recommendations for adults 60 and older. It is Moderna's mRESVIA and it is not yet available. We are working to update the RSV vaccine protocol and it be posted soon.

- Jynneos Commercialization Update Timothy Hall, Medical Countermeasures
 Coordinator at OHA provided the update on Jynneos supply. OHA has a limited
 supply of Jynneos and based on commercial setting, requests will be reviewed by
 Dr. Evans and Timothy to determine if the need outweighs the urgency.
