- **COVID-19 and RSV Vaccine Updates:** Reminders to check for updated Vaccine Information Statements (VIS) and use QR codes for ease of access.

- **Holiday Vaccine Delivery Schedule:** Irma Murauskas noted specific dates when vaccine deliveries would not occur due to holiday schedules. No orders will be delivered on Veteran's Day on Nov 11<sup>th</sup>, Thanksgiving holidays from Nov 27<sup>th</sup>-29<sup>th</sup>, and winter holidays from Dec 23<sup>rd</sup>- Jan 3<sup>rd</sup>, 2025.
- **Spikevax:** Moderna's Spikevax COVID-19 vaccine for use in Billable clients. Vaccine Access Program (VAP) providers may use their current state-supplied pediatric and 317 allocations for Billable clients, while waiting for additional Spikevax for adult intent to arrive.
- **COVID-19 vaccines:** it's still very early days for COVID-19 vaccine supply. We expect the CDC will allocate more to Oregon as the weeks go by.
- **Beyfortus:** Be sure to draw down beyfortus as soon as possible after you receive an allocation. All unclaimed Beyfortus doses will continue to be allocated and taken back on a two-week cycle.
- **Protocol Changes:**
  - ACIP recently voted to lower the age recommendation for pneumococcal vaccines and updated spacing for Bexsero (a meningococcal vaccine).

#### 4. Guest Presentation on HPV by Dr. Amanda Bruegl:

- **HPV Disease Burden:** Dr. Bruegl shared data on HPV-related cancer incidence, emphasizing the importance of HPV vaccination for all genders due to the disease's prevalence, particularly oropharyngeal cancer in Oregon.
- **Vaccination Recommendations:**
  - HPV vaccines are most effective when administered early, ideally starting between ages 9 and 10. Early vaccination completion increases protection efficacy, which is particularly important for underrepresented populations.
- **HPV Toolkit:** A toolkit developed in partnership with the Northwest Portland Area Indian Health Board was shared, aiming to improve HPV vaccination rates in tribal communities.

  - **Future Directions:** Dr. Bruegl mentioned ongoing efforts by the American Cancer Society to standardize HPV vaccination starting at age 9, although official CDC guidelines currently recommend starting between ages 11–12.
