• Updates from OIP Staff:

- Amy Kost informed participants that VFC flu vaccine is available to request in ALERT. Very few doses of flu mist are available upon special request by messaging or emailing the help desk.
- Irma Murauskas mentioned about imbalance between demand and supply of SpikeVax and reminded everyone to promptly draw down allocated vaccines for equitable redistribution. All

the unclaimed doses will continue to be taken back on a twoweek schedule.

- Jill Johnson shared that several immunization protocols were updated and posted to the OIP website recently.
 - Adult Hepatitis B Vaccines: PreHevbrio was discontinued and removed from the protocol. Adults who previously received PreHevbrio should continue their HepB series with another licensed product.
 - Meningococcal Vaccines: ACIP now recommends MenB-4C (Bexsero) as:
 - A 2-dose series spaced 6 months apart for patients 16-23 years of age based on shared clinical decision making.
 - A 3-dose series for persons aged ≥10 years at increased risk for serogroup B meningococcal disease.
 - RSV Monoclonal Antibody

CDC updated guidance regarding administration of nirsevimab (Beyfortus) outside of October through March using clinical judgment.
