Certification and Stamp Approval Application FAQs

6. As a new or re-certifying applicant, do I need to complete the **CDC Yellow Fever Vaccine: Information for Health Care Professionals Advising Travelers' Course**?
 - Yes, it is required. Find that course [here](#)
7. Do I need to attach my course **completion certificate** with my application?
 - Yes, it is required. Upload and submit the course completion certificate with your application.
8. How long does it take to **process my application**?
 - About 7 – 14 business days. You will receive a confirmation email of application status.
9. How long does it take to **receive my yellow fever stamp**?
 - About 7 – 14 business days. You will receive a confirmation email of shipping status and tracking number.

10. Can I administer yellow fever vaccine at **multiple administration sites** in Oregon?

- Yes. You can register up to 3 vaccine administration sites. Please contact us if you need to register more than 3.
- Only registered sites are eligible to receive yellow fever vaccine and supplies; vaccine and supplies cannot be transferred between sites. You will receive one stamp for each administration site.
