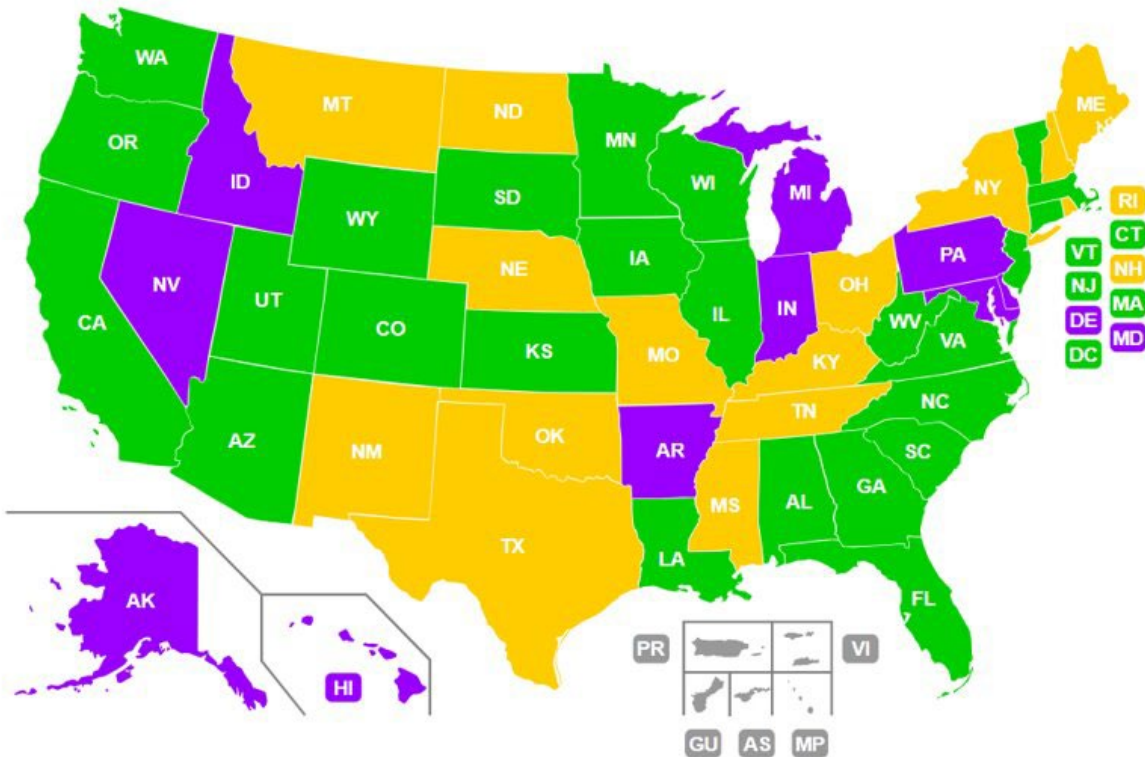

- EMS Mobilization – working with HSPR to maybe get some agreements in place, so we can surge beyond mutual aid. We have a thin agreement in place, but it's not a good long-term solution.
- Licensing of non-transporting agencies. We are one of 3-4 states that don't regulate fire agencies. It is unclear if that piece will be included.
- This is not OHA's bill, so we are in communication with Rep Graber's office and will support them. These bills should start dropping in Feb.

HB 2395- Naloxone Omnibus bill-

- EMS has a small role, option to share Narcan with the public that need it.

Rules-

Finished the associate degree rules. Drafting Hearing Officer report, then final rules will be implemented.

- Trauma Rules – Exhibit 2 & 3
 - o 2- Field Triage Criteria
 - o 3- Triage at hospital, modified, full, etc.
 - o Exhibit 4 is coming- we need some requirements for critical access hospitals.
- 250 & 255 Ambulance Service and vehicle rule changes coming
- RAC rules changed- RAC members can be created from this group, but it will not be this committee as it was before.
- 2024- EMS Education rules will be opened 265s

Mobile Integrated Healthcare- new billing code from CMS

- We don't have a license type for this but have a broad statute that speaks to this.
- Ambulance Service Plan Reviews
- Shout out to Julie and Justin for this work. We are required to respond to the counties in 60 days. We are getting closer to that response time. These plans are for the counties to enforce.

Andey Nunez has accepted a research position, thankful for his work and this is a bittersweet transition. RA3 position to be posted soon, Andey will help with that recruitment.

EMS & Trauma Systems Manager's Update

It is with bittersweet sentiment that I share the news that Andey Nunes Brewster has accepted a new position with the Data Equity Team as a Research Analyst 4. Andey has been an integral part of the EMS & Trauma Systems program since 2021, particularly with the Trauma System. Andey has demonstrated superior technical expertise and leadership with Trauma System improvement projects. In addition to his remarkable skill with databases, he has been a driving force behind several RFPs and a multitude of program improvement initiatives. We will surely miss his companionship and are comforted that he is not going too far. Please join us in congratulating Andey! Andey will be starting his new role on October 16th and has graciously committed to helping our program with onboarding a new Research Analyst 3. Recruitment for an RA3 for the EMS & trauma Systems Program will likely begin in late October.

Interviews for the EMS & Trauma Data Systems Coordinator (PA2) were conducted on September 13th and September 14th. The EMS & Trauma Systems Coordinator will be responsible for developing and implementing the program budget, managing fiscal matters relating to contract administration, and managing vendor partnerships. We are excited to announce we are in the final stages of hiring for the position and are looking forward to onboarding the newest member to our team!

We have some exciting news for private EMS agencies who are participating in CARES. Ground Emergency Medical Transportation (GEMT) has chosen the CARES registry for their program's Private Agency Quality Measure requirement. Not only is this going to improve visibility of cardiac arrests in Oregon through increased participation in CARES, but it also extends a potential reimbursement to private EMS agencies. More information can be found below.

This past June, our program purchased 4 High Performance CPR Mannequins and Training AEDs for use at Resuscitation Academy events. The new equipment was debut in Enterprise, Oregon for the Wallowa County Resuscitation Academy in August. We are happy to support our rural communities and their efforts to improve responses to sudden cardiac arrests. More information can be found below.

In collaboration with the HERO Kids Registry team, the Oregon EMS for Children Program submitted an application to the Association of Maternal & Child Health Programs regarding the HERO Kids Registry. We are thrilled (and so proud) to report that the HERO Kids Registry was recognized as an **Emerging Practice** by the organization. Well done to the HERO Kids Registry team!

Lastly, the program continues to improve internal processes. For example, in addition to the new online complaint intake system launched several months ago, we redesigned how our program receives and reviews ambulance construction exceptions. In the coming months, we intend to review and revise our ambulance agency/vehicle survey process. We are passionate about growth and will continue to report our progress on system improvement to better serve our Oregon EMS agencies and communities.

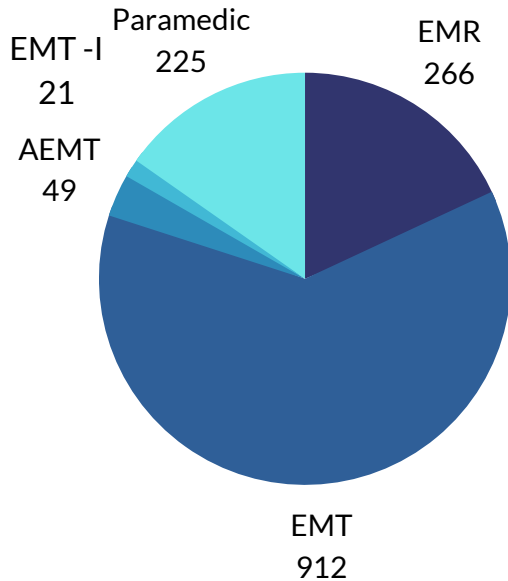

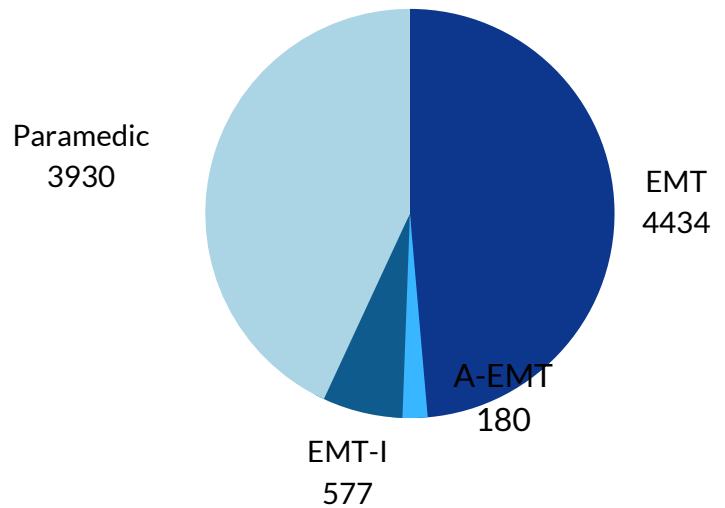

Trauma Program

- Scheduling for 2023 is still in process, with three additional full trauma reverification surveys to be completed before the end of the year, as well as four focused reviews.
- Scheduling for 2024 is in its preliminary stages, with an anticipated 13 full reverification surveys and 5 focused review surveys to be completed next year.
- Quarterly meetings for trauma program managers, coordinators and registrars are ongoing, with good attendance and participation.
- Work has begun on updates for Trauma System Rules including Exhibit 4 and the preparation of a crosswalk to the new Resources for the Optimal Care of the Injured Patient, [2022 Standards](#). We are waiting to see if ACS adds an addendum to the 2022 Standards for Level IV trauma centers before commencing with the plans for a RAC addressing Exhibit 4 currently. We hope to reconvene the RAC for Exhibits 2 and 3 in early 2024.

EMS and Trauma Data Quality tool development is ongoing. Some of this work will be highlighted in the 2022 EMS Annual Report as a special project.

NEMSIS 3.5 Implementation

As of the end of the 3rd quarter of 2023, **50 agencies are live** submitting NEMSIS 3.5 data to OR-EM SIS, and **18 more are in process**. A schedule for agency transition is in place, onboarding additional agencies and vendors are scheduled through the end of the year. Oregon Trauma Registry RFP

A major focus for the EMS & Trauma Systems Program is the Oregon Trauma Registry Request for Proposal (RFP) process. The RFP is the bidding process through which vendors compete for contracts and is a requirement by the Department of Administrative Services (DAS). Oregon EMS & Trauma Systems Program has received two responses to the RFP, which are currently under review.

Reporting

Collaboration in reporting work:

The Oregon EMS & Trauma Data Team has been engaged in reporting work including the following:

- Trauma biennial report is still under review, anticipated publication in Q3 2023.
- The 2021 EMS Annual Report is complete and undergoing final review for publication to the website.
- A draft of the 2022 EMS Annual report dashboard will be complete by the end of Q3, 2023.

Data Requests and Partnerships

In Q3 2023, the Oregon EMS & Trauma Data Team have received two new project proposals from other OHA programs, state agencies, and outside research organizations including:

- Oregon Injury & Violence Prevention Program and Johns Hopkins Applied Physics Laboratory - Opioid Overdose Surveillance Dashboard .
- Oregon Health Authority Environmental Health Program - Environmental Health Heat Event Monitoring .

Data Integration projects

- The Oregon EMS & Trauma Data Team are currently in development for a new OR-EMSIS – Oregon Trauma Registry integration to bring it into compliance with NEMSIS 3.5 national data standard update. This work will restore data exchange for ePCRs submitted under the NEMSIS 3.5 data standard
- Work to implement the integration between the License Management System and OR-EMSIS is ongoing. Since the beginning of the project, 299 agencies have been synced.
- The Oregon EMS & Trauma Systems Program has initiated a project with Oregon-Idaho High Intensity Drug Trafficking Area (HIDTA) to integrate EMS data into the Overdose Detection Mapping Application Program (ODMAP). The ODMAP system provides public health agencies with a resource for monitoring trends and spatial patterns in drug overdose events. This project will use the Rhapsody Integration Engine to geocode scene locations, mask the precise location to protect patient confidentiality, filter down to a limited set of data elements, and send this deidentified data on to the ODMAP system.

Ambulance Service Plans (ASP) Review



In accordance with [OAR 333-260-0020\(7\)](#), the OHA EMS & Trauma Systems Program reviews county Ambulance Service Area (ASA) plans for compliance with state regulations at least once every five years. The OHA EMS & Trauma Systems Program is working with counties to ensure all ASA plans have been determined to be compliant with state rules within the past five years. Counties with outdated approvals are being prioritized for review.

OHA provided, 4 HP-CPR mannequins to support the instruction and ideas around High-Performance CPR.



GEMT CCO Supplemental Payment Program provided the opportunity to present the 2022 CARES data. Collaboration between the GEMT and EMS/TS office supports the CARES program and further data collected. 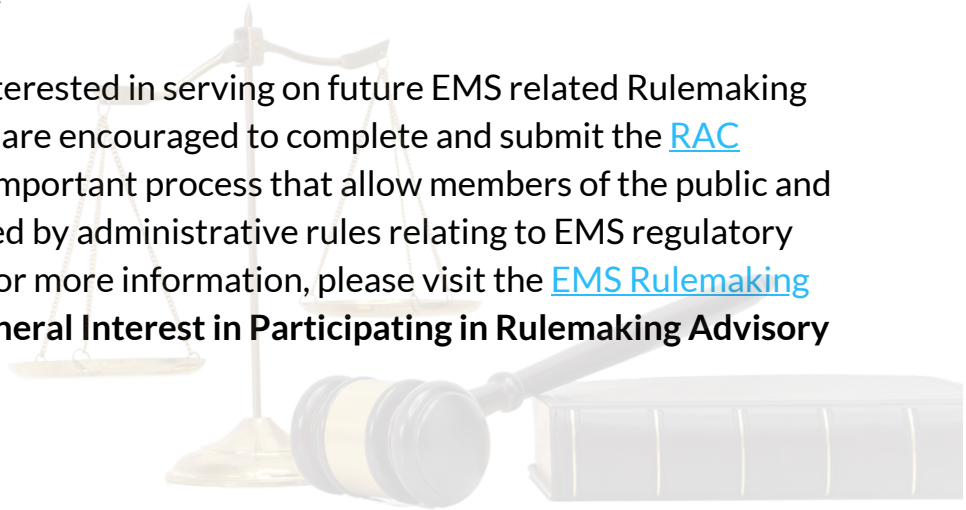

Rule and Legislation Update

Administrative Rules

- The EMS and Trauma Systems Program has concluded the Paramedic License and Military Spouse/Domestic Partner Provisions Rule Advisory Committee (RAC). RAC meetings were held on June 6th, June 21st, and July 10th. The meeting notes can be found on the [EMS Rulemaking Activity web page](#) under 'Rulemaking Advisory Committees in Progress.'
- A Notice of Proposed Rulemaking Hearing was filed with the Secretary of State's Office and a public hearing held on September 20th and written public comments were taken until 5:00 p.m., September 25th. Public testimony and written comments are being considered for possible changes to the rule. Information will be shared when final rules are in effect.
- Persons and communities interested in serving on future EMS related Rulemaking Advisory Committees (RAC) are encouraged to complete and submit the [RAC Interest Form](#).
