SAMHSA Grant: Rural Emergency Medical Services Training

Notice of Funding Opportunity | Applications due Wednesday, March 20, 2024

Eligible applicants are rural emergency medical service agencies operated by a local or tribal government (fire-based and non-fire based) and rural non-profit emergency medical service agencies.

Purpose: to recruit and train EMS personnel in rural areas with a particular focus on addressing substance use disorders (SUD) and co-occurring disorders (COD) substance use and mental disorders. With this program, SAMHSA aims to develop the capacity of EMS staff to support residents in rural communities.

Communication Cards, Pediatric Assessments & Tourniquets

Communication Cards: for pediatric patients with special communication needs (young age, nonverbal, speak a language not known by the EMS providers, etc.).

<u>Pediatric Assessment</u>: laminated patient care information sheets; includes resuscitation, burn, vital signs, GCS, APGAR, and SpO₂.

Tourniquets: each licensed ground ambulance is <u>required</u> to have 2 commercially manufactured arterial tourniquets.
