# **Overall Progress Narrative:**

In Q2 2024, recovery programs made significant progress, including the launch of the HARP application in April.¿ Major milestones for Q2 include:¿

- Completed more than 5,000 interactions with applicants and stakeholders through the ReOregon Call Center, including more than 1,000 inbound calls.¿
- Reviewed 874 eligibility questionnaires to determine preliminary eligibility to apply for HARP without requiring applicants to submit any paperwork.¿- Invited 535 applicants to apply to HARP, of which 136 have completed applications.¿
- Made more than 600 contacts between local intake centers and survivor households to help complete the HARP eligibility questionnaire or application.¿
- Moved 91 of the 136 HARP applications into eligibility review and issued eligibility determinations to 30 of those 91 as of July 8th.
- Completed an initial Policy for IHA and continued to advance program design for HOP, with Policy completion anticipated by end of summer.¿
- Received initial project submissions from PIER selection committees for 17 projects.¿

State-funded Recovery Work¿

In addition to undertaking program and policy development for CDBG-DR funds, DRR staff continues to program \$150 million in state funding to support the recovery of wildfire-impacted households and communities. Results from that funding include:¿

- \* Rent assistance, purchase and repair grants and flexible assistance provided to 1,146 wildfire-impacted individuals through the Wildfire Recovery and Resilience Account (WRRA) \$35.3 million allocation. WRRA funding also helped 867 individuals achieve permanent housing.¿
- \* The development of over 200 permanent homes for wildfire survivors (another 569 affordable housing units with a wildfire preference and funded with tax credits and other state funding will be made available).¿
- \* Funding for the redevelopment and preservation of three destroyed affordable manufactured dwelling parks in Jackson and Lane Counties¿
- \* Largely thanks to the WRRA program, when FEMA closed their Direct Housing Mission in spring 2023, 200 survivors had moved to temporary or permanent housing and no survivor households were forced out of FEMA shelters.¿
- \* Direct county allocations totaling \$19 million to fund community-driven projects, home replacement grants and land acquisition.  $\hat{A}\dot{c}$

OHCS is currently working on 8 state projects that include preserved manufactured home parks, stick built town homes, single family lots, and a tiny home village. OHCS has a total of over 200 units that are currently being developed for wildfire survivors.¿ Several of these projects will be completed by the end of 2024 and bringing more than 100 permanent homes online across 3 counties (Jackson, Lane and Lincoln).

In the last quarter, OHCS conducted additional outreach to impacted renter households to better understand the continuing unmet housing needs. ¿ In addition to the feedback provided by County partners, the responses received from this survey have further informed the design of HOP, elevating the need for both new Affordable Housing Development and Down Payment Assistance. Since the needs and wants of impacted households and the available resources for housing development look different within each disaster-impacted county, eligible county-identified subrecipients (county, other local jurisdiction, public housing authority, non-profit agency) will administer each county's allocation to develop new affordable housing that will best serve the identified needs of impacted households earning under 120% Area Median Income within each county. Down Payment Assistance will create additional homeownership opportunities for disaster-impacted households up to 120% Area Median Income.¿ Down Payment Assistance will be provided by separate subrecipients identified through a Request for Applications using their local knowledge and experience of the housing market. ¿ Subrecipients for both Affordable Housing Development and Down Payment Assistance should be selected later this year in anticipation of HOP launch in early 2025.
