Current GHAP CB Priorities

- Workforce development
- Culturally specific developer and sponsor organization capacity building
- Rural regional and organizational capacity building



Current GHAP CB Strategy

- Build knowledge and collective power for housing organizations
- Build capacity for organization self-determination
- Build long-term stability
- Build leadership capacity



2022 Feedback

- Grants must be multi-year to truly build capacity
- Streamline the process
- Make the funds as flexible as possible
- Build the workforce
- Find more pathways for distributing funds
- Elevate asset management



2023 Highlights

- Partnered with other funders to boost projects aligned with our priorities (Meyer Memorial Trust CSO project, NOAH's Manufactured Housing Training)
- Changed GHAP CB rules to include Tribes and local governments to target very rural needs
- Designed and launched new NOFA path in partnership with HOME ARP program

2024 Distribution Framework



Capacity Building Toward New and Existing Housing

- ORCA CB Grants
- General capacity building
- 20-30 awards
- Multi-year
- Up to \$150K
- Small-medium orgs
- Priority-centered
- \$3M reserved



. Training and Workforce Program Investments

- Grants to create and host professional training programs (Dev & AM)
- 2-3 grants
- Up to \$400K
- Multi-year
- Priority-aligned
- \$1.2M reserved



State Priorities & Regional Impact Projects

- One-time grants to support CB projects that are innovative, have regional impact, and align with OHCS priorities and goals
- Grants for delivery of key services tied to ARH Division projects and programs
- Pool reservation set annually

ORCA Capacity Building Grants

- Two-year grants tied to new or existing (in-service) ARH project
- Directly to eligible developers and sponsors
- Maintain current CSO and rural priorities
- Additional focus on:
 - Geographic priorities
 - Unmet needs and/or underserved communities
 - Preserving and managing assets



Grant Activities Include:

- Adding or paying for existing housing staff
- Staff and regional partner training and education
- Technical assistance and consultants
- Housing development and operations-related engagement and coordination



Grant Activities Include:

- Hardware and software
- Strengthening internal systems
- Asset management related reports
- Some project-related predevelopment soft costs (up to 10% of request)
 - E.g., financial analysis, legal consult, contracted support for project, preparing grant applications



Threshold-Based Application

Org is a CSO – or - Org is Rural

AND

- Nonprofit, housing authority, or Tribal Nation
- Bylaws or board decision to develop or own/operate ARH
- CB tied to new or existing (in-service) project



Threshold-Based Application

- Established or emerging developer or sponsors with prior experience
- Small to medium organization
- No other current ORCA CB Grant
- DEI Agreement registered (by grant execution)



Considerations to Further Prioritize Investments:

- State or agency-identified priorities (e.g., OHNA geographic priorities)
- Intends to serve an unmet need (community or geographic)
- Number of units to be preserved or created
