Commissioners Take Final Action on Rules, Contested Cases

Hear Staff Presentations and Make Retail Appointment

PORTLAND, Ore. – Commissioners of the Oregon Liquor and Cannabis Commission today at their regularly scheduled meeting heard an overview of the agency's penalty schedule, took final action on rules and ratified stipulated settlements. Commissioners additionally made one retail appointment and heard a staff presentation.

Final action by Commissioners was taken on the 2024 Hemp Implementation Package, which was necessary with the passage House Bill 4121 during this year's legislative session. The bill had several provisions that required agency rulemaking to implement. Additionally, Commissioners took final action on adopting and amending rules in OAR chapter 845, divisions 25 and 26, to address technical issues.

Commissioners approved a liquor store agent appointment for the Parkrose (Portland) store. Johns Family Incorporated (Keith Johns) was appointed as the agent for the store, as the result of the former agent's resignation.

Commissioners also heard a presentation from the agency's administrative hearings division on the agency's penalty schedule, as outlined in ORS chapter 471, and the process used in assessing administrative penalties.

The Commission also ratified four stipulated settlement agreements for alcohol and marijuana licensees and one marijuana permittee; and ratified two liquor licensing stipulated settlements. Detailed information on the specific cases below can be found <u>on the OLCC website</u>:

Alcohol Stipulated Settlement Agreements

LUCKY LOU'S DELI (L) in Springfield, will pay either a \$1,485 fine, **OR** serve a nine-day suspension for two violations if age verification equipment is installed and in use by Nov 1, 2024; or licensee will pay either a \$3,985 fine, **OR** serve a 19-day suspension for two violations if age verification equipment is not installed and in use by Nov. 1, 2024.

October 17, 2024 OLCC Commission Meeting

DENNY'S #7740 (F-COM) in Eugene, will pay a \$3,735 fine, **OR** serve a 18-day suspension for two violations.

TWO RIVERS GENERAL STORE (O) in Crescent, <u>will pay either a \$4,950 fine</u>, **OR** <u>serve a</u> <u>thirty-day suspension</u> for one violation.

Marijuana Stipulated Settlement Agreements

CANNA ROYALE / ROYAL ZEN (Producer) will receive a Letter of Reprimand **AND** will surrender their license for three violations.

CAROLL'NNE BRESHEARS (Permitee) <u>will pay a \$525 fine</u> **OR** <u>serve a 21-day suspension</u> for one violation.

Liquor Licensing Stipulated Settlement Agreements

19 ACRES CIDER COMPANY (WY) in Sherwood, will accept a restriction to their winery license.

BADLANDS in Portland, will accept a Full on-Premises License, with restrictions.
