DUTIES AND RESPONSIBILITIES

Duties and Responsibilities: As an Air Force Clinical Nurse, the candidate will be expected to provide comprehensive nursing care. This includes assessing the health and health care needs of individuals and populations, along with collecting, recording, and analyzing patient or population health data from preventive health assessments, nursing history, physical examinations and other sources. Uses data to determine nursing needs of patients/populations. Identifies expected health outcomes. Involves the patient, family, and community in setting realistic goals to achieve desired outcomes. Plans comprehensive care and attains expected outcomes. Collaborates with other disciplines. Implements and evaluates nursing interventions. Conducts group and individual health teaching for patients, families, and community. Monitors and records patient and population health status. Uses ongoing assessment data to evaluate progress toward expected outcomes and revises plan of care as needed. Documents nursing actions and activities. As a member of the 142 MDG Detachment-1 and the 102 Oregon CERFP, the candidate will be expected to serve and fulfill the duties relating to the following mission statement: When directed by the.......

Secretary of Defense, coordinated by the Chief of the National Guard Bureau, and upon consent of the Governor(s) during major or catastrophic CBRN incidents, the CERFP alerts, recalls and deploys critical command and control, search and extraction, mass casualty decontamination, and medical stabilization in order to save lives and mitigate human suffering.

Special Duty Summary: Provides professional nursing care within scope of practice, established standards of care and federal and state laws within a clinical and mass casualty setting. Chemical, biological, radiological, explosive, and nuclear force package (CERF-P) specializes in disaster response to mass casualty incidents. The unit is expected to operate in austere and extreme environments in chemical protective equipment. Members are expected to respond to base within 6 hours from notification of activation.

Specialty Qualifications:

Knowledge: Knowledge of principles and practices of nursing is mandatory.

Education: Must be a graduate of a baccalaureate degree program in nursing (BSN) accredited by a national nursing accrediting agency recognized by the US Department of Education. Registered nurses who are graduates of an associate's degree in nursing (ADN) and no do not have a BSN are not eligible for accession unless they also have a post-baccalaureate (master's or doctorate) degree in nursing that is also nationally accredited and recognized by the US Department of Education.

Experience: For award of AFSC 46N3 (Qualified) requires a minimum of 12 months active-duty Air Force or civilian experience as a registered nurse. For award of an AFSC 46N3 specialty shred out (E or J), a minimum of 6 months in the respective clinical specialty. The 6 months experience in the specialty may be included in the total experience required as part of or in addition to the 12 months experience as a registered nurse. Civilian clinical nursing experience, time spent in the Air Force Nurse Transition Program, or the applicable specialty training/fellowship program is creditable.
