Topic: 6d - All-Terrain Vehicle (ATV) Grant Recommendation

Background: The All-Terrain Vehicle Grant Subcommittee met August 15, 2024, in Salem and via Zoom to review 8 grant applications totaling \$441,791.86. Two were Operations and Maintenance, three Emergency Medical Services, two Law Enforcement (LE), and one Safety Education grant request. The ATV Grant program has \$15,000,000 in spending limitation for ATV grants for the 2023-2025 biennium. So far \$13,184,557 has been allocated, leaving \$1,815,443 in remaining funds.

The committee scored each grant request based on the applicant's presentation and application submitted. The scoring criteria were established in the 2016-2025 Oregon Statewide Trails Plan. The applications were ranked by the average of the scores given by the committee.

Six of the applications were for equipment purchases, mostly side-by-sides for Emergency Medical Services and Law Enforcement. One was for equipment storage and tools for providing youth safety training courses. Another was for Jefferson County Sheriff's Office Law Enforcement Patrols, which was their first application to the program.

Prior Action by Commission: At the April 2023 Commission Meeting, \$8,039,013.71 was recommended and approved for Operations and Maintenance funding. At the June 2023 Commission Meeting, \$3,975,801.19 was recommended and approved for Law Enforcement and other projects. At the February 2024 Commission Meeting, \$794,750.62 was recommended and approved for multiple project categories. All these allocations are for the 23-25 biennium.

Action Requested: Commission approval for the ranking and distribution of ATV grants as recommended by the ATV Grant Subcommittee.
