Background:

Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

SCENIC WATERWAYS NOTIFICATION

On June 20th, 2024, Notification of Intent 2A-1966-24 was approved to build an accessory dwelling unit to match the existing house at 5875 NW Zamia Ave, Redmond. This NOI was approved because the project was deemed non-visible due to the topography on site. The proposal complies with all relevant Middle Deschutes River Scenic River Area rules.

On July 11th, 2024, Notification of Intent 2A-300-24 was approved for a non-farm dwelling and new pole barn 3095 NW Ivancovich Way, Redmond. This NOI was approved because the project was deemed non-visible due to the distance from the river and the existing topography. The proposal complies with all relevant Middle Deschutes Scenic River Area rules.

On July 18th, 2024 Notification of Intent 07-756-24 was approved for fencing, clearing for agricultural use and roof replacement at 395 Quail Lane, Grants Pass, OR 97526 within the Lower Rogue River State Scenic Waterway.

On July 19th, 2024, Notification of Intent 2B-1117-24 was approved for improvements at the existing Sunriver Wastewater Treatment Facility located at 57850 W. Cascade Rd., Sunriver. The improvements include building a sludge hopper building, storage shed, and minor site improvements. This NOI was approved because a site visit deemed the project non-visible due to existing vegetation and structures between the river and the site. The proposal complies with all relevant Upper Deschutes Recreational River Area rules.

On July 22, 2024, Notification of Intent 2C-217-24 for construction of a pole barn for agricultural purposes within the Lower Deschutes SSW corridor was approved. The barn is for a historic land use, shall blend with the surrounding landscape, and has a 400' setback from the river.

On July 22, 2024, Notification of Intent 2A-301-24 for construction of a post and beam barn within the Middle Deschutes River SSW corridor was approved. The barn has a setback of 220' from the river and will be minimally visible. No vegetation disturbance except fescue removal for pads.

On July 26th, 2024, Notification of Intent 2B-1118-24 was approved for a 200 sqft addition and updated siding and roofing at 14211 Stillwater Lane, La Pine. This NOI was approved because the project was deemed non-visible due to the distance from the river and the existing topography. The proposal complies with all relevant Upper Deschutes River Community Area rules.

Timber Related Scenic Waterway Notifications

Mountain Region: On June 25th, 2024, Notification of Intent 07-755-24 along with a Supplemental Timber Harvest Application was approved to allow fuels reduction on approximately 0.5 acres of land located at T35S R7W Sec. 02,03 Tax lot 625. The fuel reduction area is located on property within the Rogue State Scenic Waterway but was determined not visible from the river due to vegetation screening between the fuel reduction area and the banks of the Rogue River.

Coastal Region: Nehalem SSW Timber Harvest, approximately 5 acres of thinning (approved).

Valley Region: Sandy SSW timber harvest. On June 27th, 2024, NOI# 53-233-24 approval of a 55-acre thinning out of 113.2 acres of ownership. The project is not visible from the river due to riparian vegetation along the subject property (T1S, R4E, Sec. 14 Tax Lots 500, 1100, 1800) and the project area.
