1:35 – 2:20 Retail Storefront Design for Quality & Historic Character

The retail storefront is a feature that is particularly subject to change over time; thus, there is seldom an historic storefront to save when a building is rehabilitated. Too often, however, the replacement storefront becomes an incompatible new feature that reflects little understanding of the proportion, materials, and design typical of historic storefronts. It is also very likely to be designed and built without much thought of durability. By thoughtfully choosing materials and construction details it is possible to build something that it not a maintenance nightmare. We will look at actual historic storefronts from various periods of history to get a better sense of what constitutes a compatible design that is consistent with the architecture of the building and worth building well.
